8	WHEREAS, The City and County of San Francisco desires to continue a certain project		
9	designated the Threat Management/Stalking Vertical Prosecution Program, to be funded in		
10	part from funds made available through the Office of Criminal Justice Planning (OCJP); and,		
11	WHEREAS, OCJP requires that the City and County of San Francisco, through the		
12	Office of the District Attorney, provide no less than a twenty percent cash match for the grant;		
13	and		
14	WHEREAS, All positions supported by these funds shall be coded "G" in the District		
15	Attorney's budget; and,		
16	WHEREAS, The terms of the grant prohibit inclusion of indirect costs in the grant		
17	budget; now, therefore, be it		
18	RESOLVED, That the Board of Supervisors hereby authorizes the District Attorney of the City		
19	and County of San Francisco to retroactively accept and expend funds from OCJP for the		
20	purposes of the Threat Management/Stalking Vertical Prosecution Program; and, be it		
21	FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of		
22	indirect costs in the grant budget; and be it		
23	FURTHER RESOLVED, That the District Attorney is authorized to execute on behalf of		
24	the City and County of San Francisco the necessary Grant Award Agreements for purposes of

2	augmentations or amendments thereof; and be it		
3	FURTHER RESOLVED, That the District Attorney is authorized and empowered to		
4	execute, deliver and perform, in the name of the City and County of San Francisco, all		
5	applications, contracts, agreements, amendments and payment requests necessary for the		
6	purpose of securing the Threat Management/Stalking Vertical Prosecution Program grant		
7	funds and to implement and carry out the purposes specified in the applicable grant		
8	application; and be it		
9	FURTHER RESOLVED, That any liability arising out of the performance of the Grant		
10	Award Agreement, including civil court actions for damages, shall be the responsibility of the		
11	grant recipient and the authorizing agency; and be it		
12	FURTHER RESOLVED, That grant funds received hereunder shall not be used to		
13	supplant expenditures controlled by this body.
