2 AMENDING RESOLUTION 362-99, RELATING TO THE ESTABLISHMENT OF THE  
3 POTRERO POWER PLANT CITIZENS ADVISORY TASK FORCE, SPECIFYING  
4 APPOINTMENT PROCESS FOR TASK FORCE MEMBERSHIP AND CORRECTING A

7 WHEREAS, The Board of Supervisors adopted Resolution 362-99,  
8 thereby establishing a Potrero Power Plant Citizens Advisory Task  
9 Force which will automatically expire on December 31, 2000; and,

10 WHEREAS, The Potrero Power Plant Citizens Advisory Task Force  
11 consists of 13 members as follows: the Mayor of San Francisco or his  
12 designee, a member of the Board of Supervisors, the Director of the  
13 Department of Health or his designee, the head of the San Francisco  
14 Labor Council or his designee, a representative of the Southeast  
15 Alliance for Environmental Justice, a representative of the Public  
16 Utilities Commission, and 7 residents of the Potrero Hill and Lower  
17 Potrero Hill neighborhood; and,

18 WHEREAS, due to a clerical error, a representative of the  
19 Southeast Alliance for Environmental Justice was printed twice; now,  
20 therefore, be it

21 RESOLVED, That the Task Force shall include only one  
22 representative of the Southeast Alliance for Environmental Justice,  
23 selected by the Southeast Alliance for Environmental Justice; and, be


