FURTHER RESOLVED, That the Director of Health is authorized to enter into the Agreement in behalf of the City; and, be it

FURTHER RESOLVED, That the Controller is directed to designate the positions created under the grant as a "G" or grant-funded positions, which would terminate when the grant expires.
