3 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**
4 **accept and expend retroactively a new grant in the amount of \$40,000 from the**
5 **California Department of Health Services (CDHS) to develop a 5 year strategic plan to**
6 **reduce intimate partner violence in the community and to enter into an agreement for**
7 **the use of these funds; for the period of July 1, 2002 through September 30, 2003.**

9 WHEREAS, SFDPH has applied for and been awarded a grant from CDHS in the
10 amount of \$40,000 to develop a 5 year strategic plan, including vision, goals, and specific
11 objectives to reduce intimate partner violence in the community; and,

12 WHEREAS, As a condition of receiving the grant funds, CDHS requires the City to
13 enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the
14 Board of Supervisors in File No. 021322, which is hereby declared to be a part of this
15 resolution as if set forth fully herein; and,

16 WHEREAS, The grant budget includes provision for indirect costs of \$2,902; now,
17 therefore, be it

18 RESOLVED, That SFDPH is hereby authorized to accept and expend retroactively a
19 grant in the amount of \$40,000 from CDHS; and, be it

20 FURTHER RESOLVED, That SFDPH is hereby authorized to accept and expend the
21 grant funds in accordance with the requirements set forth in the Agreement pursuant to San
22 Francisco Administrative Code section 10-170-1; and, be it


23 FURTHER RESOLVED, That the Director of Health is authorized to enter into the


FURTHER RESOLVED, That the Controller is directed to designate the position funded under this agreement as a "G" or grant-funded position which would terminate when the agreement expires.
