4 **certified by the State of California and massage establishments that employ only state-**
5 **certified massage practitioners from requirements for obtaining a permit from the**
6 **Health Department; and making environmental findings.**

11 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. The Planning Department has determined that the actions contemplated in
13 this ordinance comply with the California Environmental Quality Act (California Public
14 Resources Code Section 21000 et seq.). Said determination is on file with the Clerk of the
15 Board of Supervisors in File No. ____ and is incorporated herein by reference.

16 Section 2. The Health Code is hereby amended by amending Article 29, to read as
17 follows:

9 **SEC. 1900. DEFINITIONS.**

10 For the purposes of this Article:

11 ~~(a)~~ "City" means the City and County of San Francisco.

12 ~~(b)~~ "Convicted" means having pled guilty or having received a verdict of guilty,
13 including a verdict following a plea of nolo contendere, to a crime.

14 ~~(c)~~ "Director" means the Director of Public Health or any individual designated by
15 the Director to act on his or her behalf.

16 ~~(d)~~ "Massage" means any method of pressure on or friction against, or stroking,
17 kneading, rubbing, tapping, pounding, vibrating, or stimulating of the external soft pads of the
18 body with the hands or with the aid of any mechanical electrical apparatus or appliances, with
19 or without such supplementary aids as rubbing alcohol, liniments, antiseptics, oils, powder,
20 lotions, ointments, or other similar preparations.

21 ~~(e)~~ "Massage establishment" means a fixed place of business where more than
22 one person engages in or carries on, or permits to be engaged in or carried on, the practice of
23 massage.

24 ~~(f)~~ "Massage practitioner" means any individual who, for any monetary
25 consideration whatsoever, engages in the practice of massage. "Massage practitioner" shall

1 include both general massage practitioners and advanced massage practitioners, as provided
2 in Section 1901.

3 ~~(g)~~ "Non-profit organization" means any fraternal, charitable, religious,
4 benevolent, or any other nonprofit organization having a regular membership association
5 primarily for mutual social, mental, political, and civic welfare, to which admission is limited to
6 the members and guests and revenue accruing therefrom to be used exclusively for the
7 benevolent purposes of said organization and which organization or agency is exempt from
8 taxation, under the Internal Revenue Laws of the United States as a bona fide fraternal,
9 charitable, religious, benevolent, or non-profit organization.

10 ~~(h)~~ "Outcall massage service" means any business, not permitted as a massage
11 establishment or solo practitioner massage establishment under the provisions of this Article,
12 wherein the primary function of such business is to engage in or carry on massage not at a
13 fixed location but at a location designated by the client or customer.

14 ~~(i)~~ "Permittee" means the owner, proprietor, manager, or operator of a massage
15 establishment, outcall massage service, or solo practitioner massage establishment.

16 ~~(j)~~ "Person" means any individual, partnership, firm, association, joint stock
17 company, corporation, or combination of individuals of whatever form or character.

18 ~~(k)~~ "Recognized school for massage" means any school or institution of learning
19 which teaches the theory, ethics, practice, profession, and work of massage, which requires a
20 resident course of study of not less than 100 hours to be completed before the student shall
21 be furnished with a diploma or certificate of graduation, and which has been approved
22 pursuant to California Education Code Sections 94301 et seq., or, if said school or institution
23 is not located in California, has complied with standards commensurate with those required in
24 said Sections 94301 et seq. and has obtained certification under any similar state approval
25 program, if such exists.

1 (+) "Solo practitioner massage establishment" means a fixed place of business
2 where a person holding an advanced massage practitioner permit engages in or carries on, or
3 permits to be engaged in or carried on, the practice of massage. Said fixed place of business
4 may be shared by two to four advanced massage practitioners, or two to four advanced
5 massage practitioners and one or more health or healing arts practitioners, except as
6 otherwise provided pursuant to Section 1913(e).

7 **SEC. 1901. PERMIT REQUIRED FOR MASSAGE PRACTITIONER; EXEMPTIONS.**

8 (a) It shall be unlawful for any individual who is not certified as a massage practitioner
9 or therapist by the State of California pursuant to the California Business and Professions Code to
10 engage in the practice of massage without first obtaining a permit from the Director.

11 (b) An individual may receive a permit as either a general massage practitioner or
12 an advanced massage practitioner, as provided in Section 1902. As used in this Article, the
13 term "massage practitioner" shall refer to both general massage practitioners and advanced
14 massage practitioners, unless otherwise specifically provided in *this Article*.

15 (c) A permit is not required where the individual is a licensed or certificated health
16 care practitioner practicing massage as part of his or her health care practice. For purposes of
17 this Section, "health care practitioner" shall mean any person whose activities are licensed or
18 regulated under Division 2 of the California Business and Professions Code or any initiative
19 act referred to in that division.

20 (d) A permit is not required where the individual is a barber, cosmetologist,
21 esthetician, or manicurist licensed or certificated pursuant to Division 3, Chapter 10, of the
22 California Business and Professions Code, practicing massage as part of his or her work as a
23 barber, cosmetologist, esthetician, or manicurist and within the scope of any relevant state
24 restrictions on the practice of massage by members of those professions.

1 (e) An individual practicing massage under the direction of a non-profit
2 organization, and the organization itself are exempt from permit and license fees under this
3 Article, but the individual and the organization must obtain the necessary permits and licenses
4 and otherwise comply with all relevant requirements.

5 **SEC. 1902. APPLICATION FOR MASSAGE PRACTITIONER PERMIT; GENERAL**
6 **AND ADVANCED PRACTITIONERS NOT CERTIFIED BY THE STATE.**

7 (a) Unless certified as a massage practitioner or therapist by the State of California
8 pursuant to the California Business and Professions Code, ~~E~~every applicant for a massage
9 practitioner permit shall file an application with the Director upon a form provided by the
10 Director and pay a non-refundable application fee, as set forth in Section ~~1927~~1925.

11 (b) The application for a massage practitioner permit shall set forth, under penalty
12 of perjury, the following:

- 13 (1) Name and residence address of the applicant;
- 14 (2) A unique identifying number from at least one government-issued form of
15 identification, such as a social security card, a state driver's license or identification card, or a
16 passport;
- 17 (3) Written evidence that the applicant is at least 18 years of age;
- 18 (4) Applicant's height, weight, and color of hair and eyes;
- 19 (5) Business, occupation, or employment of the applicant for the five years
20 immediately prior to the date of application; this information shall include, but not be limited to,
21 a statement as to whether or not the applicant, in working as a massage practitioner or
22 bodywork technician or similar occupation under a permit or license, has had such permit or
23 license revoked or suspended, and the reasons therefor; and
- 24 (6) All felony or misdemeanor convictions.
- 25

1 (c) An applicant for a general massage practitioner permit shall provide, as part of
2 the application, the name and address of the recognized school for massage attended, the
3 dates attended, and the original of the diploma or certificate of completion awarded the
4 applicant showing that the applicant has completed not less than 100 hours of instruction. An
5 applicant for an advanced massage practitioner permit shall provide, as part of the
6 application, the name and address of the recognized school or schools for massage attended,
7 the dates attended, and the original of the diploma(s) or certificate(s) of completion awarded
8 the applicant showing that the applicant has completed not less than 200 hours of instruction.
9 The additional 100 hours of instruction required for the advanced massage practitioner permit
10 may be completed at one or more schools. If the applicant already holds a current general
11 massage practitioner permit, he or she need only submit documentation for the additional 100
12 hours of instruction necessary for the advanced massage practitioner permit.

13 (d) The Director shall administer a culturally-sensitive test to all applicants, in the
14 applicant's own language, to confirm basic proficiency in massage before issuing a permit.

15 (e) The Director is hereby authorized to require in the application any other
16 information including, but not limited to, any information necessary to discover the truth of the
17 matters set forth in the application.

18 **SEC. 1903. ISSUANCE OF MASSAGE PRACTITIONER PERMIT *FOR***
19 ***PRACTITIONERS NOT CERTIFIED BY THE STATE.***

20 (a) Within 14 days following a hearing, or, if no hearing is held, within 60 business
21 days following receipt of a completed application for a massage practitioner permit, for a
22 practitioner who is not certified as a massage practitioner or therapist by the State of California
23 pursuant to the California Business and Professions Code the Director shall either issue the permit
24 or mail a written statement of his or her reasons for denial thereof to the applicant. If the
25 Director takes neither action, the permit shall be deemed issued.

1 (b) No massage practitioner permit shall be issued if the Director finds:

2 (1) The applicant has provided materially false documents or testimony; or

3 (2) The applicant has not complied fully with the provisions of this Article; or

4 (3) Within five years immediately prior to the date of application, the applicant
5 has had any license or permit related to the practice of massage revoked; or

6 (4) The applicant has been convicted of any of the following offenses or
7 convicted of an offense outside the State of California that would have constituted any of the
8 following offenses if committed within the State of California:

9 (A) Any felony involving the use of coercion or force and violence upon
10 another person; or

11 (B) Any misdemeanor sexual battery; or

12 (C) Any offense involving sexual misconduct with children; or

13 (D) Any offense requiring registration pursuant to Section 290 of the
14 California Penal Code.

15 (c) The Director may issue a massage practitioner permit to any individual
16 convicted of one of the offenses listed in Subsection (b)(4) of this Section if the Director finds
17 that the offense was not violent, the conviction occurred at least five years prior to the date of
18 application, and the applicant has not been convicted subsequently of one of those offenses.

19 (d) If an application for a massage practitioner permit is denied, within 30 days of
20 the date of receipt of the notice of denial, the applicant may appeal the decision by notifying
21 the Director in writing. The notice shall set forth in detail the ground or grounds for the appeal.
22 Within 30 days of receipt of the notice of appeal, the Director shall conduct a hearing to
23 consider the appeal. At least 10 days prior to the hearing, the Director shall notify the
24 applicant of the time and place of the hearing. The Director shall oversee the hearing, provide
25

1 the applicant an opportunity to speak at the hearing, and issue a ruling within 30 days of its
2 conclusion. The Director's ruling shall be final.

3 **SEC. 1904. TEMPORARY MASSAGE PRACTITIONER PERMIT; TRAINEE PERMIT**
4 **FOR PRACTITIONERS NOT CERTIFIED BY THE STATE.**

5 (a) Upon completion and submission of an application for a massage practitioner
6 permit *for a practitioner who is not certified as a massage practitioner or therapist by the State of*
7 *California pursuant to the California Business and Professions Code,* as required in Section 1902 of
8 this Article, and upon payment of all fees for the permit, an applicant may request a temporary
9 massage practitioner permit. If requested, the Director shall issue the temporary massage
10 practitioner permit which is valid for the period during which the application is under review,
11 but in no event for more than 60 days. The Director may revoke the permit at any time if he or
12 she finds that the applicant has failed to meet any of the requirements of Section 1903 of this
13 Article.

14 (b) The Director may adopt rules and procedures for issuing trainee permits, not
15 to exceed three months in duration, to persons who have otherwise completed an application
16 for a massage practitioner permit and who are currently registered in a recognized school of
17 massage to fulfill the training requirement.

18 **SEC. 1905. IDENTIFICATION CARD FOR PRACTITIONERS NOT CERTIFIED BY**
19 **THE STATE.**

20 The Director shall provide all massage practitioners, *who are not certified as a massage*
21 *practitioner or therapist by the State of California pursuant to the California Business and Professions*
22 *Code,* granted a permit with an identification card. The identification card must *be* presented to
23 any City health inspector upon request at all times during the regular business hours of any
24 massage establishment or solo practitioner massage establishment.

1 **SEC. 1906. MESSAGE PRACTITIONER LICENSE FEE.**

2 Every massage practitioner shall pay to the Tax Collector an annual license fee, as
3 set forth in Section ~~1927~~1925.

4 **SEC. 1907. REVOCATION OF MESSAGE PRACTITIONER PERMIT, FOR**
5 **PRACTITIONERS NOT CERTIFIED BY THE STATE.**

6 (a) The Director may revoke or suspend any massage practitioner permit *for a*
7 *practitioner who is not certified as a massage practitioner or therapist by the State of California*
8 *pursuant to the California Business and Professions Code*, after a public hearing, if the Director
9 finds:

10 (1) The massage practitioner willfully violated any of the provisions of this
11 Article; or

12 (2) The massage practitioner has provided materially false documents or
13 testimony; or

14 (3) Within five years immediately prior to the date of application, the massage
15 practitioner has had any license or permit related to the practice of massage revoked; or

16 (4) The massage practitioner has violated a rule or regulation adopted by the
17 Director pursuant to Section ~~1926~~1924.

18 (b) Before any hearing is conducted under this Section, the Director shall provide
19 the massage practitioner at least 20 days written notice. The notice shall include the time,
20 place, and grounds for the hearing. If requested by the massage practitioner, the Director
21 shall make available all documentary evidence against him or her no later than 15 days prior
22 to the hearing. At the hearing, the massage practitioner shall be provided an opportunity to
23 refute all evidence against him or her. The Director shall oversee the hearing and issue a
24 ruling within 20 days of its conclusion. The Director's ruling shall be final.

1 (c) The Director may suspend summarily any massage practitioner permit issued
2 under this Article pending a noticed hearing on revocation or suspension when in the opinion
3 of the Director the public health or safety requires such summary suspension. Any affected
4 permittee shall be given notice of such summary suspension in writing delivered to said
5 permittee in person or by registered letter.

6 **SEC. 1908. REGISTRATION OF MASSAGE ESTABLISHMENTS THAT EMPLOY ONLY**
7 **STATE CERTIFIED PRACTITIONERS.**

8 (a) All massage establishments that employ only massage practitioners who are certified by the
9 State of California pursuant to the California Business and Professions Code, must provide copies of
10 those certificates to the San Francisco Department of Public Health for all massage practitioners
11 employed by the establishment. The massage establishment must update this information annually.

12 (b) All massage establishments that employ only massage practitioners who are certified by the
13 state must notify the Department if any state certified massage practitioner loses their state
14 certification.

15 (c) Any massage establishment that employs any massage practitioner who is not certified by
16 the state must obtain a permit to operate a massage establishment from the San Francisco Department
17 of Public Health in accordance with this Article 29.

18 (d) Upon notice from California Massage Therapy Council, or any successor agency authorized
19 under the California Business and Professions Code to certify massage practitioners, that the state
20 certification of a massage practitioner has been suspended or revoked, the Department shall send
21 written notice to the massage establishment that it must obtain a permit from the San Francisco
22 Department of Public in order to continue to operate, and that it must apply for the permit within thirty
23 (30) days of the notice. Failure to either apply for a San Francisco permit or to regain exempt status
24 by employing only state-certified massage practitioners within thirty (30) days, may result in
25 administrative penalties as set forth in this Article 29, Section 1926.

1 **SEC. ~~1908~~1909. PERMIT REQUIRED FOR A MASSAGE ESTABLISHMENT, SOLO**
2 **PRACTITIONER MASSAGE ESTABLISHMENT, OR OUTCALL MASSAGE SERVICE,**
3 **EXEMPTIONS FOR PRACTITIONERS NOT CERTIFIED BY THE STATE.**

4 (a) It shall be unlawful for any person to engage in, conduct, or carry on, or to
5 permit to be engaged in, conducted, or carried on, in or upon any premises in the City the
6 operation of a massage establishment, solo practitioner massage establishment, or outcall
7 massage service without first obtaining a permit from the Director, *unless all persons employed*
8 *by that establishment or service are certified as massage practitioner(s) or therapist(s) by the State of*
9 *California pursuant to the California Business and Professions Code.*

10 (b) Hospitals, nursing homes, and other State-licensed health care facilities
11 providing massage services to their patients shall not be required to obtain a permit under this
12 Section, where the services are provided by a licensed or certificated health care practitioner
13 or an individual practicing massage under the direction of a health care practitioner. For
14 purposes of this Section, "health care practitioner" shall mean any person whose activities are
15 licensed or regulated under Division 2 of the California Business and Professions Code or any
16 initiative act referred to in that division.

17 (c) A permit shall not be required under this Section where the services are
18 provided on the premises (1) by a licensed or certificated health care practitioner or (2) by a
19 barber, cosmetologist, esthetician, or manicurist, licensed or certificated pursuant to Division
20 3, Chapter 10, of the California Business and Professions Code, practicing massage as part
21 of his or her work as a barber, cosmetologist, esthetician, or manicurist, and within the scope
22 of any relevant state restrictions on the practice of massage by members of those
23 professions. A non-profit organization providing massage services on its premises, and the
24 individuals providing the massage services, are exempt from permit and license fees under
25

1 this Article, but the organization and the individuals must obtain the necessary permits and
2 licenses and otherwise comply with all relevant requirements.

3 **SEC. ~~1909~~1910. APPLICATION FOR MASSAGE ESTABLISHMENT, SOLO**
4 **PRACTITIONER MASSAGE ESTABLISHMENT, OR OUTCALL MASSAGE SERVICE**
5 **PERMIT FOR PRACTITIONERS NOT CERTIFIED BY THE STATE.**

6 (a) Unless certified as a massage practitioner or therapist by the State of California
7 pursuant to the California Business and Professions Code, ~~E~~every applicant for a massage
8 establishment, solo practitioner massage establishment, or outcall massage service permit
9 shall file an application with the Director upon a form provided by the Director and pay a non-
10 refundable application fee, as set forth in Section ~~1927~~1925.

11 (b) The application shall set forth, under penalty of perjury, the following:

12 (1) The exact nature of the services to be rendered;

13 (2) The address of the proposed place of business and facilities thereof

14 (3) The number of individuals to be employed by the business, and, in the
15 case of a solo massage practitioner establishment, the names of any massage practitioners
16 who shall operate under that permit;

17 (4) The name, residence address, and date of birth of each applicant;

18 (5) Any history of previous massage permits or licenses in San Francisco or
19 elsewhere, including whether any such permit or license has been revoked and the reasons
20 therefor, for each applicant; and

21 (6) All felony or misdemeanor convictions for the applicant.

22 (c) The Director is hereby authorized to require in the application any other
23 information including, but not limited to, information related to the health, hygiene, and
24 sanitation of the premises and any information necessary to confirm the accuracy of the
25 matters set forth in the application.

1 (d) If an applicant for a massage establishment or outcall massage service permit
2 is a corporation, the name of the corporation shall be set forth exactly as shown in its articles
3 of incorporation together with the names and residence addresses of each of the officers,
4 directors, and each stockholder holding more than 10 percent of the stock of the corporation.
5 If the application is a partnership, the application shall set forth the name and the residence
6 address of each of the partners, including limited partners. If one or more of the partners is a
7 corporation, the provisions of this Section pertaining to corporate applicants applies. The
8 same permit and criminal history information required of individual applicants shall be
9 provided for each officer, director, and stockholder holding more than 10 percent of the stock
10 of the corporation, or for each partner, including limited partners.

11 (e) In addition to the information required under subsections (b) and (c), an
12 applicant for a solo practitioner massage establishment permit shall provide proof that he or
13 she holds a current, valid advanced massage practitioner permit issued by the Director under
14 Section 1901.

15 (f) Applicants shall also submit proof of compliance with any applicable Planning
16 Code requirements regarding notice and posting of the proposed establishment.

17 (g) An advanced massage practitioner holding a solo practitioner massage
18 establishment permit shall not be required to pay any additional permit fee for an outcall
19 massage service permit.

20 **SEC. ~~1910~~1911. OPERATING REQUIREMENTS FOR ALL MASSAGE**
21 **ESTABLISHMENTS.**

22 *No permit to conduct a massage establishment shall be issued unless an inspection by the*
23 *Director reveals that the All massage establishments must comply with each of the following*
24 *reasonable health and safety requirements:*

25 (a) Toilet facilities shall be provided for patrons in convenient locations.

1 (1) Construction of rooms used for toilets, tubs, steam baths, and showers shall
2 be made waterproof with hard nonabsorbent materials which are easily cleaned and shall be
3 installed in accordance with the San Francisco Building Code.

4 (2) Plumbing fixtures shall be installed in accordance with the San Francisco
5 Plumbing Code.

6 ~~(1) — For toilet rooms, toilet room vestibules, and rooms containing bathtubs, there shall
7 be a waterproof floor covering, which will be carried up all walls to a height of at least five inches.
8 Floors shall be coved at the juncture of the floor and wall with a inch minimum radius coving.~~

9 ~~(2) — Steam rooms and shower compartments shall have waterproof floors, walls, and
10 ceilings approved by the Director.~~

11 ~~(3) — Floors of wet and dry heat rooms shall be adequately pitched to one or more floor
12 drains properly connected to the sewer. Dry heat rooms with wooden floors need not be provided with
13 pitched floors and floor drains.~~

14 ~~(4) — A source of hot water must be available within the vicinity of dry and wet heat
15 rooms to facilitate cleaning.~~

16 ~~(b) — Toilet facilities shall be provided in convenient locations. When five or more
17 employees or patrons of different genders are on the premises at the same time, separate toilet facilities
18 shall be provided. A single toilet shall be provided for each 1.5 or more persons of the same gender on
19 the premises at any one time. (3) Urinals may be substituted for toilets after one toilet has been
20 provided.~~

21 (4) Doors to toilet rooms shall open inward and be self-closing.

11 abeyance, shall be liable to the City for its costs incurred in enforcing this Article including but
12 not limited to the costs of inspection, investigation, administration, hearing officer,
13 administrative proceedings, court proceedings, monitoring and attorneys' fees. Within ten
14 business days of the termination of the administrative hearing or other proceeding, the
15 Department of Public Health shall calculate the amount of costs.

16 **SEC. 1928.2. VIOLATIONS AND CRIMINAL PENALTIES.**

17 (a) Any permittee, as defined in Section 1900(~~i~~), of a massage establishment or
18 outcall massage service or any employer of a massage practitioner who shall violate Health
19 Code Section 1901 which requires a permit to engage in the practice of massage, Health
20 Code Section 1905 which requires presentation of an identification card to any City health
21 inspector, Health Code Section ~~1908~~1909 which requires *practitioners not certified by the State of*
22 *California pursuant to the California Business and Professions Code to obtain* a permit to operate a
23 massage establishment, solo practitioner massage establishment, or outcall massage service,
24 Health Code Section ~~1914(e)~~1911(g) which prohibits the use of any room in which massage
25 services are provided to be used as a sleeping room, Health Code Section ~~1911~~1914 which

1 requires every permit holder or employer to ensure that a massage practitioner, *who is not*
2 *certified by the State of California*, has obtained a permit, Health Code Section ~~1916~~1915 which
3 requires a register of practitioners to be available for inspection, Health Code Section
4 ~~1917~~1916 which prohibits the employment of any individual under the age of 18, Health Code
5 Section ~~1918~~1917, which requires display of a permit and prohibits operation between the
6 hours of 10 p.m. and 7 a.m., or any rule or regulation adopted pursuant to Section ~~1926~~1924,
7 shall be guilty of a misdemeanor and upon conviction shall be punished by a fine not to
8 exceed \$1,000 or by imprisonment in the County Jail not to exceed six months, or by both. A
9 person convicted of violating this Section shall be deemed guilty of a separate offense for
10 every day such violation shall continue.

11 (b) Nothing in this Section shall preclude the prosecution of anyone under the
12 laws of the State of California or of the United States of America.

13 **SEC. 1929. COOPERATIVE EFFORTS WITH LAW ENFORCEMENT.**

14 The Director of Public Health shall work with the Chief of Police on issues of
15 common concern affecting the massage industry, such as protections against violence in
16 massage establishments, crimes against massage practitioners, forced labor, or trafficking.

17 During the six-month period between adoption of this Article and its effective date,
18 the Director of Public Health shall work with the Chief of Police to develop procedures to verify
19 that permit applicants do not have prior criminal convictions that would disqualify the
20 applicants from receiving a permit under this Article.

21 **SEC. 1930. DISCLAIMER.**

22 In regulating massage establishments and massage services as provided in this
23 Article, the City is assuming an undertaking only to promote the general welfare. It is not
24 assuming, nor is it imposing on its officers and employees, an obligation for breach of which it
25

1 is liable in money damages to any person who claims that such breach proximately caused
2 injury.

3 **SEC. 1931. SEVERABILITY.**

4 If any of the provisions of this Article or the application thereof to any person or
5 circumstance is held invalid, the remainder of this Article, including the application of such part
6 or provisions to persons or circumstances other than those to which it is held invalid, shall not
7 be affected thereby and shall continue in full force and effect. To this end, the provisions of
8 this Article are severable.

9 Section 3. Effective Date. This ordinance shall become effective 30 days from the
10 date of passage.

11 Section 4. This section is uncodified. In enacting this Ordinance, the Board intends to
12 amend only those words, phrases, paragraphs, subsections, sections, articles, numbers,
13 punctuation, charts, diagrams, or any other constituent part of the Health Code that are
14 explicitly shown in this legislation as additions, deletions, Board amendment additions, and
15 Board amendment deletions in accordance with the "Note" that appears under the official title
16 of the legislation.
