

1 [Approval of two contracts with Siemens Medical Solutions USA, Inc. to support and maintain
2 clinical and financial software applications in use by the Department.]

5 **Resolution authorizing the San Francisco Department of Public Health (DPH), to**
6 **retroactively enter into two contracts with Siemens Medical Solutions USA, Inc.**
7 **(Siemens) for the continued licensing and maintenance of proprietary Siemens**
8 **applications for the term July 1, 2007 through June 30, 2012.**
9

10 WHEREAS, DPH has entered into prior Agreements with Siemens as the
11 principal vendor of clinical and financial applications for the Department of Public Health
12 and the Community Health Network known as the Product and Professional Services
13 and Remote Computing Option; and
14

15 WHEREAS, The Health Commission, The Department of Telecommunication
16 and Information Systems (DTIS), and The Civil Service Commissions (CSC) have
17 approved the proposed contracts for these systems; and
18

19 WHEREAS, the proposed contracts handle over \$440 million dollars of revenue
20 for the Department, store the Life Time Clinical record for patients of the Department
21 and are critical applications for the Department which effect patient care; and

23 WHEREAS, DPH has been able to negotiate with Siemens a five year contract
24 agreement for both contracts, which maintains operational expenditures at base budget
25 levels; and

2 WHEREAS, the cost of said contracts, which when combined would not
3 exceed Eighteen Million Six Hundred Twenty Seven Thousand One Hundred Forty
4 Two Dollars (\$18, 627, 142); could require anticipated expenditures of the City and
5 County of San Francisco in excess of ten million dollars (\$10,000,000); and
6

7 WHEREAS, Section SEC. 9.118.B of the San Francisco Charter requires that
8 such contracts be approved by the Board of Supervisors; and now, therefore; be it
9

10 RESOLVED, that DPH that the Board of Supervisors hereby authorizes the
11 Director of Public Health and the Office of Contract Administration, on behalf of the City
12 and County of San Francisco, to retroactively execute two Agreements between the City
13 and County of San Francisco and Siemens Medical Solutions USA, Inc. as set forth in
14 File No. 01164 for the period July 1, 2007 though June 30, 2012
