17 two year-term ending April 5, 2007;

18 Kelly Quirke, succeeding himself, term expiring, seat 4, must be a representative of a  
19 non-profit organization involved in urban forestry or other environmentally-related issues, for a  
20 two-year term ending April 5, 2007;

21 Stephen Griswold, succeeding himself, term expiring, seat 5, must be a representative  
22 of the Golden Gate National Recreation Area, for a two year-term ending April 5, 2007;

23 Michael Sullivan, succeeding himself, term expiring, seat 6, must be a representative of  
24 the community, for a two year-term ending April 5, 2007;
