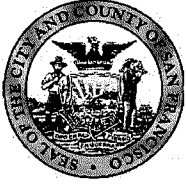

8 Monitoring Committee, pursuant to the provisions of Administrative Code, Sections 20.300, et  
9 seq., for the terms specified:

10 Mico Rolanda Williams, seat 1, succeeding Julia D'Antonia, resigned, must be  
11 homeless or formerly homeless within the three years prior to appointment and living with their  
12 homeless child under the age of 18, for the unexpired portion of a two-year term ending  
13 November 23, 2016.

14 Darcel Jackson, seat 2, succeeding Deborah Muise, term expired, must be homeless  
15 or formerly homeless within the three years prior to appointment and have a disability, for the  
16 unexpired portion of a two-year term ending November 23, 2016.

17 Anakh Sul Rama, seat 6, succeeding Raija Freeman, resigned, must be selected from  
18 a list of candidates that are nominated by non-profit agencies that provide advocacy or  
19 organizing services to homeless people, for the unexpired portion of a two-year term ending  
20 November 23, 2016.
