4 **to establish the Working Families Credit Program, and by adding Section 10.100-347, to**  
5 **create the Working Families Credit Program Fund.**

9 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. The San Francisco Administrative Code is hereby amended by adding  
12 Section 12S.1, to read as follows:

13 **SEC. 12S.1. WORKING FAMILIES CREDIT PROGRAM.**

14 *The Working Families Credit Program is hereby created in the Office of the Treasurer.*  
15 *Beginning in Fiscal Year 2005-2006, the program will provide an incentive payment to qualified*  
16 *working families from the Treasurer’s Working Families Credit Fund established in*  
17 *Section 10.100-347. The incentive payment shall based on a percentage of the family’s federal Earned*  
18 *Income Tax Credit (EITC). The Treasurer shall work with the Local EITC Working Group, other City*  
19 *departments, and community stakeholders to develop the program. This legislation is not intended to*  
20 *result in a reduction in the level of public assistance to which participants in the Working Families*  
21 *Credit Program would otherwise be entitled..*

1 Section 2. The San Francisco Administrative Code is hereby amended by adding  
2 Section 10.100-347, to read as follows:

3 **SEC. 10.100-347. TREASURER'S WORKING FAMILIES CREDIT FUND.**

4 (a) Establishment of Fund. The Treasurer's Working Families Credit Fund is established as a  
5 category eight fund for the purpose of receiving all public monies and gifts, donations and  
6 contributions of money which may from time to time be received by the City and County through the  
7 Treasurer for the purpose of implementing the Working Families Credit Program established in  
8 Chapter 12S.

9 (b) Use of Fund. All expenditures from such fund shall be made for the purpose of  
10 administering and implementing the Working Families Credit Program established in Chapter 12S.
