10 WHEREAS, The Commission on Peace Officer Standards and Training will reimburse
11 any eligible agency, Section 13523 Penal Code, for the purchase of an interactive multimedia
12 training delivery system (herein referred to as a multimedia system) which is capable of running
13 POST multimedia courseware and

15 WHEREAS, Participating agencies that have multiple locations where agency personnel
16 regularly convene for in-service training may apply and be reimbursed for one multimedia
17 system for each location, and the San Francisco Sheriff's Department has applied for and been
18 granted authorization for reimbursement for 10 multimedia systems and

20 WHEREAS, a quote for the 10 multimedia systems listing all of the separate components
21 has been submitted and approved by POST and

23 WHEREAS, the terms of the legislation establishing the program do not allow indirect or
24 administrative costs; therefore, be it


RESOLVED, that the Sheriff's Department is hereby directed to purchase 10 multimedia


1 that the purchase amount on the submitted invoice has been paid and that the systems have been


