Be it ordained by the People of the City and County of San Francisco:

Section 1. Findings.

The Planning Department has determined that the actions contemplated in this Ordinance are in compliance with the California Environmental Quality Act (California Public Resources Code sections 21000 et seq.). Said determination is on file with the Clerk of the Board of Supervisors in File No. _____ and is incorporated herein by reference.

Section 2. The San Francisco Park Code is hereby amended by amending Section 12.06, to read as follows:

B.

(a) The following fees shall be charged for admission to Coit Tower:

Age Category	Admission Fee
Adult	\$4.50 <u>5.00</u>
Senior <u>(65+)</u>	\$3.50 <u>3.00</u>
<u>Youth (12 – 17 years)</u>	<u>\$3.00</u>
Child (6 – 12 <u>5 – 11</u> years)	\$2.00 <u>1.50</u>
Child <u>(4 years and under-6 years)</u>	\$0.00


