1 [Contract - Retroactive - Golden Gate Petroleum - Citywide Renewable Diesel - Not to Exceed
2 \$45,000,000]

3 **Resolution retroactively authorizing the Office of Contract Administration to enter into**
4 **a multi-year contract, pursuant to Charter, Section 9.118(b), with Golden Gate**
5 **Petroleum, to supply the City Departments with Renewable Diesel for a three-year term**
6 **of April 1, 2019, through March 31, 2022, in an amount not to exceed \$45,000,000 with**
7 **two one-year options to extend, and require Board of Supervisors approval of each**
8 **one-year contract extension that increases the contract amount by at least \$500,000,**
9 **and authorization to increase the total not-to-exceed amount to \$60,000,000 upon**
10 **exercising the first option and \$75,000,000 upon exercising the second option,**
11 **conditional on future Board of Supervisors approval.**

13 WHEREAS, The Board of Supervisors previously adopted Resolution 082-16 to
14 approve a contract for the City's purchase of renewable diesel for the term of April 1, 2016
15 through March 31, 2019; and

16 WHEREAS, The Office of Contract Administration solicited proposals to provide
17 renewable diesel; and

18 WHEREAS, The Office of Contract Administration intends to award the contract for
19 renewable diesel for all City departments to Golden Gate Petroleum, with a not-to-exceed
20 amount of \$45,000,000; and

21 WHEREAS, The contract will have a term of three years, retroactively approved from
22 April 1, 2019, through March 31, 2022, with two one-year options to extend for a total of five
23 years; and

24 WHEREAS, Approval from the Board of Supervisors will be required for each one-year
25 contract extension that increases the contract amount by at least \$500,000; and

1 WHEREAS, The Office of Contract Administration is authorized to increase the total
2 not-to-exceed amount to \$60,000,000 upon exercising the first option and \$75,000,000 upon
3 exercising the second option, conditional on future Board of Supervisors approval; and

4 WHEREAS, Charter Section 9.118(b), requires Board approval by resolution of
5 contracts estimated to exceed \$10,000,000; now, therefore, be it

6 RESOLVED, That the Board of Supervisors approves the award of the contract to
7 Golden Gate Petroleum for \$45,000,000 in substantially the form on file with the Clerk of the
8 Board in File No. 190334 in such final form as approved by the Purchaser and Director of the
9 Office of Contract Administration and the City Attorney; and, be it

10 FURTHER RESOLVED, That within thirty (30) days of the contract being fully executed
11 by all parties, the Purchaser and Director of the Office of Contract Administration shall provide
12 the final contract to the Clerk of the Board for inclusion into the official file.


