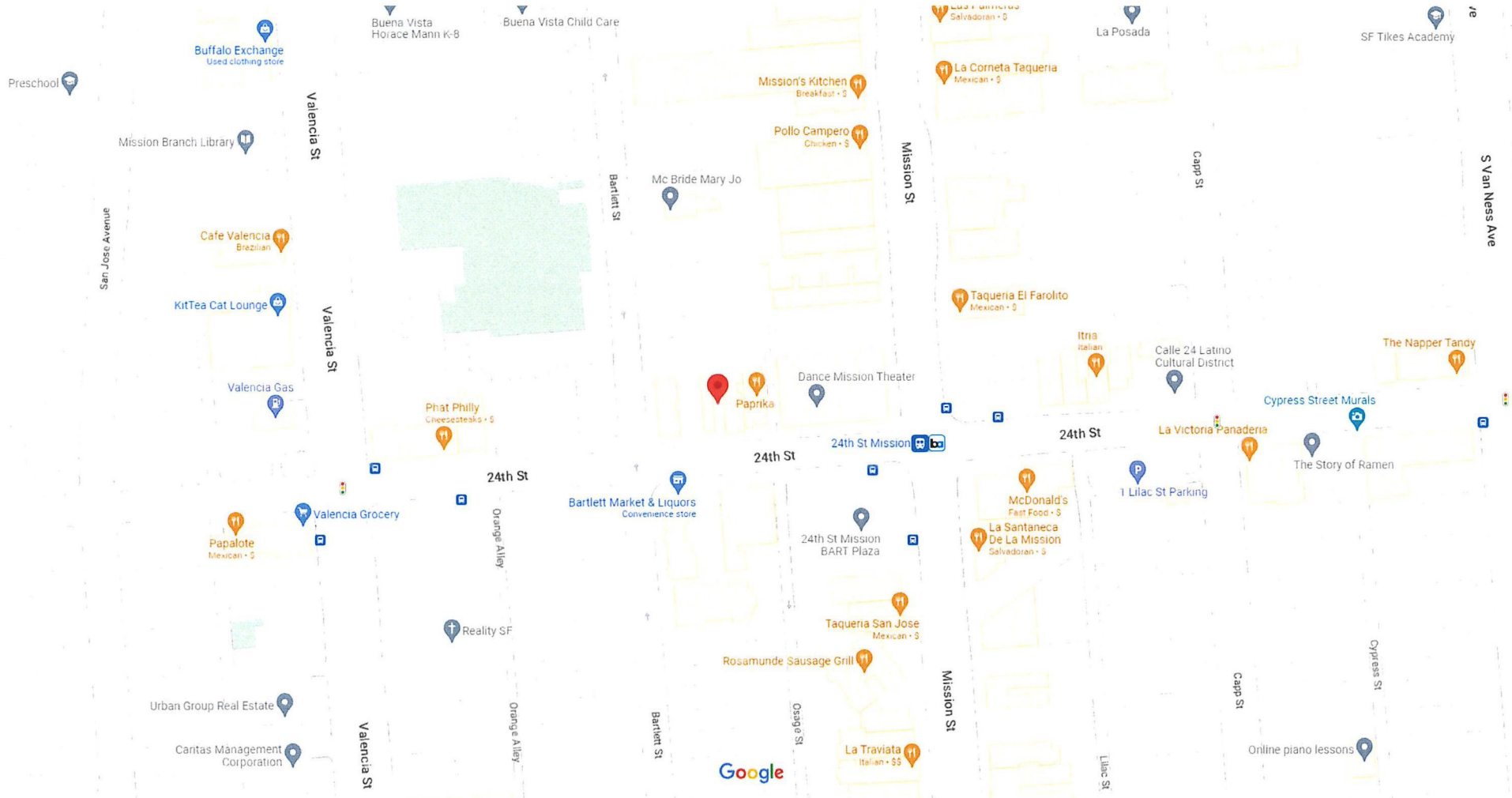

Hi and thank you for your attention to this email.

The Planning Department recommends to approve the type 48 proposed at 3336 24th Street. This recommendation is for a change of ownership only. The legal commercial use for the said address is a bar use as defined in section 102 of the Planning Code.

The existing bar use is located in the [Mission Alcohol Restrict Special](#) Use District. Per section 249.60,

(c) **Existing Liquor Establishments.** For purposes of this subsection, "liquor establishment" shall mean any establishment licensed by the State of California to sell alcoholic beverages except for those uses listed in subsection (b)(1)-(2) above. Any liquor establishment lawfully existing prior to the effective date of this Ordinance No. [180-13](#) and licensed by the State of California for the retail sale of alcoholic beverages, so long as otherwise lawful, is considered a nonconforming use pursuant to Section [180](#), and is subject to the restrictions of Sections [181](#) and [183](#) with the following exceptions:

(a) **Discontinuance and Abandonment of a Nonconforming Use, Generally.** Whenever a nonconforming use has been changed to a conforming use, or discontinued for a continuous period of three years, or whenever there is otherwise evident a clear intent on the part of the owner to abandon a nonconforming use, such use shall not after being so changed, discontinued, or abandoned be reestablished, and the use of the property thereafter shall be in conformity with the use limitations of this Code for the district in which the property is located. Where no enclosed building is involved, discontinuance of a nonconforming use for a period of six months shall constitute abandonment.



Everything will be operated indoors and the entertainment will only consist of background music and two, maximum three, TV's. 

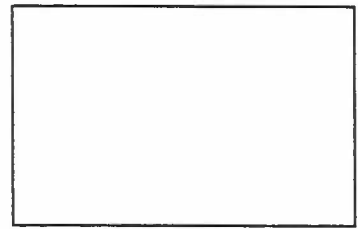
