WHEREAS, The people of San Francisco have a long history of leadership in protecting the oceans through actions such as monitoring the water quality at all beaches, supporting protection of Chilean Sea Bass, supporting the California Ocean Protection Act, and supporting the Gulf of the Farallones, Cordell Bank and Monterey Bay National Marine Sanctuaries; and

WHEREAS, The health of the Pacific Ocean is directly tied to San Francisco's economy, public health, and environment; and

WHEREAS, there is increasing scientific evidence that human activities are irreparably harming our marine ecosystems and ocean life; and

WHEREAS, There is strong scientific evidence that marine protected areas, including marine reserves and water quality protection areas, restore and protect the natural diversity and abundance of marine life, and the structure, function and integrity of marine ecosystems; and

WHEREAS, In 1999, California adopted the Marine Life Protection Act to provide improved protection for the diversity and abundance of California's ocean habitats through a network of marine protected areas with six goals:

- To protect the natural diversity and abundance of marine life, and the structure, function, and integrity of marine ecosystems.
- 2. To help sustain, conserve, and protect marine life populations, including those of economic value, and rebuild those that are depleted.
