WHEREAS, James Gabbert was born in Chico, California on February 7th, 1936, and studied Electrical Engineering at Stanford University; and

WHEREAS, James Gabbert founded his first radio station, KPEN-FM, in 1957 with an investment of \$2,000; and,

WHEREAS, James Gabbert changed the call letters of KPEN to K101, becoming the first radio station to integrate its call letters with its dial position, and increased its wattage from 1,000 to 125,000 watts and moved K101 to San Francisco; and,

WHEREAS, By 1979, James Gabbert had also acquired KSAY-AM, KIKI-AM, and KPIG-FM; and,

WHEREAS, James Gabbert sold his radio stations and bought San Francisco KEMO-TV channel 20 in 1980 and changed the call letters to KOFY in 1986; and.

WHEREAS, James Gabbert was approached by Warner Brothers in 1994 and asked to be the San Francisco Bay Area affiliate for the new Warner Brothers Television Network, and KOFY was renamed WB20 KOFY; and,

WHEREAS, James Gabbert was the first to bring a stereo TV broadcast to the Bay Area; and,

WHEREAS, Since June 18, 1995, WB20 KOFY has broadcast the annual San Francisco Lesbian, Gay, Bisexual, Transgender Pride Parade and Celebration; and,

WHEREAS, James Gabbert made a gift of 70 million dollars to the Trust for Public Land; and,

WHEREAS, James Gabbert has been honored by The Gavin Report, Billboard Magazine, The California Broadcasting Association, and President John F. Kennedy; now, therefore, be it

RESOLVED, That the City and County of San Francisco Board of Supervisors commends James Gabbert for his leadership and service to the San Francisco radio and telecommunications industry.
