9 WHEREAS, The Department of Public Health, Community Mental Health
10 Services, has applied for and been awarded an AB2034 grant from The State
11 Department of Mental health in the total amount of \$3,961,167 for integrated
12 services for seriously mentally ill and dual/multiply diagnosed adults; and,

14 WHEREAS, The grant terms prohibit including indirect costs in the grant
15 budget; now, therefore, be it

16 RESOLVED, That the Department of Public Health, Community Mental Health
17 Services, is hereby authorized to accept retroactively and expend the grant funds
18 pursuant to San Francisco Administrative Code section 10.170-1; and, be it

20 FURTHER RESOLVED, That the Board of Supervisors hereby waives
21 inclusion of indirect costs in the grant budget; and, be it

22 FURTHER RESOLVED, That the Board of Supervisors authorizes the Director
23 of Health to enter into similar agreements with the State Department of Mental
24 Health if the grant recurs or is renewed.



3 terminate when the grant expires, and, be it


4 FURTHER RESOLVED, That funds in the amount of \$490,667 are hereby placed on
