12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. The Administrative Code is hereby amended by adding Section 10.100-83,
14 to read as follows:

15 **SEC. 10.100-83. KINDERGARTEN TO COLLEGE FUND.**


16 (a) Establishment of Fund. The Kindergarten to College Fund is established as a category
17 eight fund to receive all private grants, gifts, and bequests of money and property which may be offered
18 to the City and County of San Francisco to support the Kindergarten to College Program.

19 (b) Use of the Fund. The Kindergarten to College Program provides college savings
20 accounts for kindergarten students in participating schools. The fund is to be used exclusively to
21 support the Kindergarten to College Program, including but not limited to, student incentives,
22 scholarships, and program operations.

23 (c) Administration of Fund. The Office of the Treasurer and Tax Collector shall
24 administer the fund.

1 Section 2. Effective Date. This ordinance shall become effective 30 days after
2 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
3 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
4 of Supervisors overrides the Mayor's veto of the ordinance.


