TO PERFORM TERMINAL 1/BOARDING AREA B REDEVELOPMENT PROGRAM MANAGEMENT SUPPORT SERVICES IN AN ESTIMATED AMOUNT OF \$32 MILLION OVER THE NEXT TEN YEARS, SUBJECT TO APPROVAL BY THE SAN FRANCISCO BOARD OF SUPERVISORS. THIS MODIFICATION IS TO INCREASE THE COMPENSATION BY THE NOT-TO-EXCEED AMOUNT OF \$7,807,579 FOR A NOT TO EXCCED CONTRACT AMOUNT OF \$12,260,757, TO EXTEND THE TERM OF AGREEMENT FOR YEAR 2 SERVICES THROUGH 07/07/2015 AND TO MODIFY THE BILLING RATE AS SHOWN ON APPENDIX B.3. 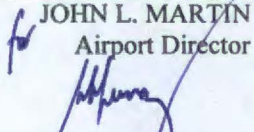

Third Amendment

THIS AMENDMENT (this "Amendment") is made as of **July 8, 2014**, in San Francisco, California, by and between **T1 Partners, Joint Venture** ("Contractor"), and the City and County of San Francisco, a municipal corporation ("City"), acting by and through its Airport Commission or the Commission's designated agent, hereinafter referred to as "Commission."

RECITALS

WHEREAS, City and Contractor have entered into the Agreement (as defined below); and

WHEREAS, City and Contractor desire to modify the Agreement on the terms and conditions set forth herein to incorporate Year 2 services through July 7, 2015 and to adjust base labor and overhead rates as shown on Appendix B.3; and

WHEREAS, the Commission adopted Resolution Number 13-0087 on April 16, 2013 awarding the Agreement for the period of one (1) year from the Notice to Proceed date with the option for nine (9) additional one-year extensions for a total term of ten (10) years; and

WHEREAS, Modification Nos. 1 and 2 were for administrative changes; and

WHEREAS, the Commission authorized this Modification 3 pursuant to Resolution Number 14-0067 on April 22, 2014; and

WHEREAS, pursuant to San Francisco Charter Section 9.118, the Board of Supervisors by its Resolution No. 187-13, adopted June 11, 2013, approved the contract to Consultant; and

WHEREAS, approval for this Amendment was obtained when the Civil Service Commission approved Contract number PSC #4048-12/13 on November 19, 2012; and

NOW, THEREFORE, Contractor and the City agree as follows:

1. Definitions. The following definitions shall apply to this Amendment:

a. Agreement. The term "Agreement" shall mean the Agreement dated April 16, 2013 between Contractor and City, as amended by the:

**First Amendment, dated August 26, 2013
Second Amendment, dated February 21, 2014**

b. Other Terms. Terms used and not defined in this Amendment shall have the meanings assigned to such terms in the Agreement.




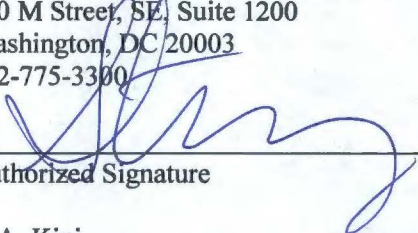


2. Term of the Agreement. The term of this Agreement has been extended for Year 2 services through July 7, 2015.

3. Section 5. Compensation is hereby amended to increase compensation by the not-to-exceed amount of Seven Million Eight Hundred Seven Thousand Five Hundred Seventy-Nine Dollars (\$7,807,579) for a not-to-exceed contract amount of Twelve Million Two Hundred Sixty Thousand Seven Hundred Fifty-Seven Dollars (\$12,260,757) and to modify base labor and overhead rates as shown on the attached Appendix B.3 attached to this third amendment.

4. Effective Date. Each of the modifications set forth in Section 1 shall be effective on and after **July 8, 2014**.

5. Legal Effect. Except as expressly modified by this Amendment, all of the terms and conditions of the Agreement shall remain unchanged and in full force and effect.
