9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Linda Gebroe v. City and County of
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-21-591651 by the
13 payment of \$40,000. The lawsuit involves alleged personal injury on a City sidewalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on May
15 7, 2021, and the following parties were named in the lawsuit: plaintiff: Linda Gebroe;
