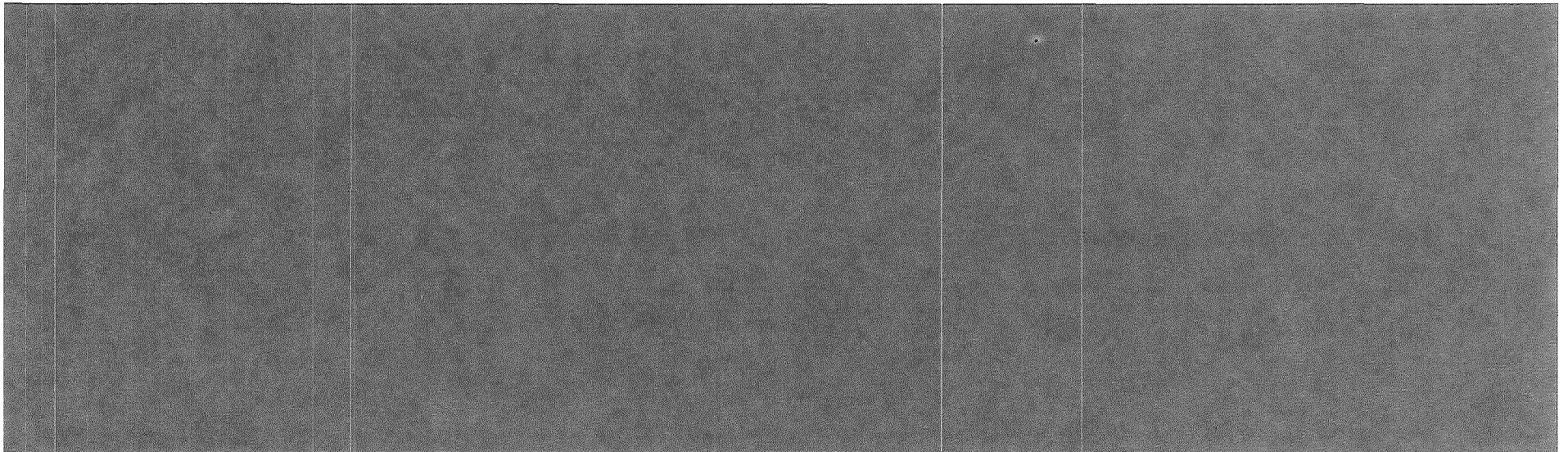


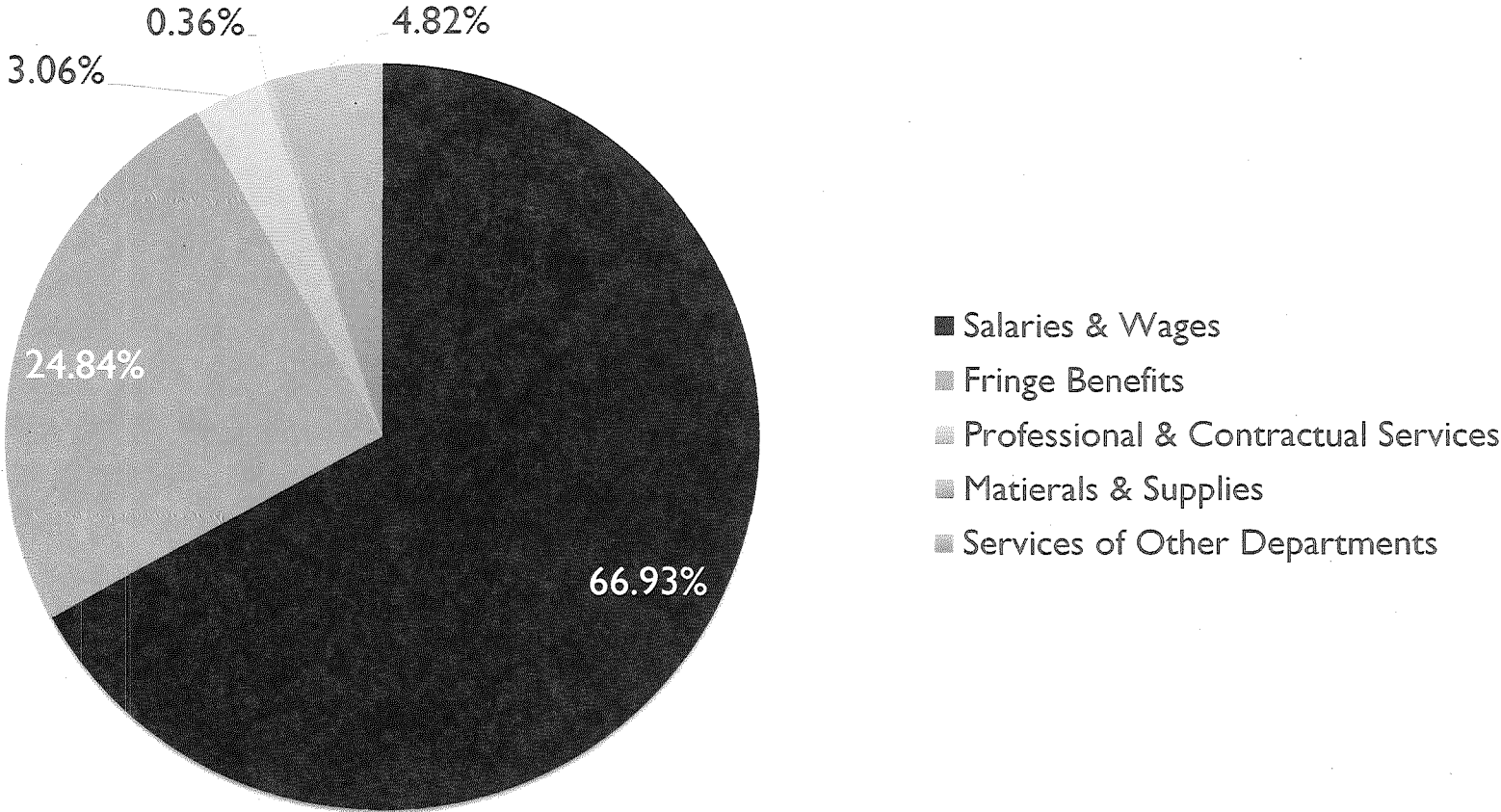

BAIL REFORM & PRETRIAL RELEASE

- **PROVIDE REPRESENTATION TO CLIENTS AT BOOKING**
- **REPORT FROM UC BERKELEY'S GOLDMAN SCHOOL OF PUBLIC POLICY FINDINGS:**
 - **INDIVIDUALS WHO RECEIVE ARREST-RESPONSIVE SERVICES ARE TWICE AS LIKELY TO BE RELEASED AT ARRAIGNMENT**
 - **THE PRU IS PROJECTED TO SAVE APPROXIMATELY 11,220 JAIL-BED DAYS PER YEAR AT THE ANNUAL COST OF APPROXIMATELY \$335,000**
 - **THE PRU'S EFFORTS TO ADVOCATE FOR THE DISMISSAL OF PAROLE HOLDS REDUCED PRE-TRIAL INCARCERATION BY 44% AMONG ELIGIBLE PAROLEES WHO WERE HELD IN CUSTODY FOR VIOLATION OF THEIR PAROLE ORDERS**

- **PLAY A VITAL ROLE IN HELPING THE CITY LEAD THE STATE AND THE NATION IN TREATING ALL PEOPLE FAIRLY AND WITH DIGNITY**

THE INTEGRITY UNIT: GOALS & OUTCOMES

- REQUEST, REVIEW, AND ANALYZE RECORDS RELEASED PURSUANT TO SB 1421 / PC §832.7 FROM LAW ENFORCEMENT AGENCIES
- EFFECTIVELY USE SB 1421 / PC §832.7 RECORDS IN OPEN AND CLOSED CASES TO IMPACT THOSE CASES
- CREATE AND MAINTAIN AN INTAKE FORM DATABASE ON POLICE MISCONDUCT
- TRY RESISTING ARREST CASES IN WHICH VIOLENCE AGAINST OFFICERS IS ALLEGED
- REVIEW CASES IN WHICH POLICE AND PROSECUTORIAL MISCONDUCT IS ALLEGED
- PREVENT WRONGFUL CONVICTIONS BECAUSE OF POLICE AND PROSECUTORIAL MISCONDUCT
- PROVIDE LEGAL REPRESENTATION TO INDIVIDUALS SEEKING RESENTENCING IN SAN FRANCISCO UNDER SB 1437 / PC §1170.95
- SEEK RELEASE FOR THOSE ELIGIBLE OR WRONGLY CONVICTED ARE RELEASED, AS PROVIDED BY PC §1170.95
- PROVIDE LEGAL ADVICE AND REPRESENTATION TO INDIVIDUALS SEEKING PAROLE OR RELEASE THROUGH YOUTHFUL OFFENDER PAROLE HEARINGS
- PROVIDE LEGAL ADVICE AND REPRESENTATION AT *FRANKLIN* HEARINGS
- ASSIST AND PREPARE COMPREHENSIVE MITIGATION PACKETS TO INCREASE LIKELIHOOD OF RELEASE FROM CUSTODY
- PURSUE LOCAL AND STATEWIDE LEGISLATIVE AND POLICY REFORMS RELATED TO THE CRIMINAL JUSTICE SYSTEM
- COLLECT AND ANALYZE DATA RELATED TO CLIENT INTERACTION WITH THE CRIMINAL JUSTICE SYSTEM TO EVALUATE OUTCOMES
- PARTICIPATE IN CITY-WIDE TASK FORCES TO ADDRESS THE DISPARATE RACIAL AND ECONOMIC IMPACT OF THE CRIMINAL JUSTICE SYSTEM
- COORDINATE WITH CRIMINAL JUSTICE REFORM PARTNERS ACROSS THE COUNTRY TO IMPLEMENT BEST PRACTICES IN SAN FRANCISCO
- DEVELOP DATABASE ON RACIAL DISPARITY IN JURY SELECTION TO ENSURE JURIES ARE COMPOSED OF A FAIRER CROSS-SECTION OF THE COMMUNITY
