22 Be it ordained by the People of the City and County of San Francisco:

23 Section 1. The Board of Supervisors hereby adopts and implements Amendment No. 1

24 to the 2014-2019 Memorandum of Understanding (“MOU”) between the City and County of

25 San Francisco and Crafts Coalition: Bricklayers and Allied Crafts, Local 3; Hod Carriers, Local

1 166; Northern California Carpenters Regional Council, Local 22; Carpet, Linoleum and Soft
2 Tile Workers, Local 12; Plasterers and Cement Masons, Local 300; Glaziers, Architectural
3 Metal and Glass Workers, Local Union No. 718; International Alliance of the Theatrical Stage
4 Employees, Moving Picture Technicians, Artist and Allied Crafts of the United States, Its
5 Territories and Canada, Local 16; International Association of Bridges, Structural Ornamental,
6 Reinforcing Iron Workers, Riggers and Machinery Movers, Local 377; Pile Drivers, Divers,
7 Carpenters, Bridge, Wharf and Dock Builders, Local Union No. 34; Plasterers and
8 Shophands, Local 66; United Union of Roofers, Waterproofers and Allied Workers, Local 40;
9 Sheet Metal Workers International Union, Local 104; and Teamsters, Local 853, to implement
10 a “Union Access to New Employees” program.

11 Amendment No. 1 to the MOU so implemented is on file with the Clerk of the Board of
12 Supervisors in Board File No. _____.

14 Section 2. The Board of Supervisors hereby authorizes the Department of Human
15 Resources to make non-substantive ministerial or administrative corrections to the MOU.

17 Section 3. Effective Date. This ordinance shall become effective upon enactment.
18 Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance
19 unsigned or does not sign the ordinance within ten days of receiving it, or the Board of
20 Supervisors overrides the Mayor’s veto of the ordinance.
