8 placing them at risk of developing serious behavior problems and interfering with their
9 academic development; and,

10 WHEREAS, Proposition 13 drastically reduced funds for schools, forcing the School
11 District to eliminate this service so important to elementary school children; and,

12 WHEREAS, School social workers are trained in group, family and individual
13 counseling and develop programs for violence prevention, social skills development and for
14 children with special needs; and,

15 WHEREAS, Cities, counties and states throughout the country report great success
16 with placing school social workers in elementary schools

17 WHEREAS, Diana Ming Chan, member of the Delinquency Prevention Commission
18 and retired social worker, developed a pilot program to hire school social workers in
19 elementary schools , and

20 WHEREAS, The San Francisco Unified School District (SFUSD) agreed to
21 participate in the program, and

22 WHEREAS, Mrs. Chan and her husband, Clarence K. Chan, will generously donate
23 \$500,000.00 seed money for the project, and

2 2002-2003, and
