4 **Resolution confirming the reappointment of James McCray to the Board of Directors of**  
5 **the Municipal Transportation Agency, term ending March 1, 2010.**

6 WHEREAS, Article VIII.A of the City Charter, approved November 1999, establishes  
7 the Municipal Transportation Agency ("MTA") which includes the Municipal Railway and the  
8 Department of Parking and Traffic; and,

10 WHEREAS, The MTA includes a Board of Directors governed by a board of seven  
11 directors appointed by the Mayor and confirmed by the Board of Supervisors;

12 WHEREAS, At least four of the directors must be regular riders of the municipal railway  
13 and must continue to ride the municipal railway during their terms; and,

14 WHEREAS, The directors must possess significant knowledge of, or professional  
15 experience in, one or more of the fields of government, finance or labor relations; and,

16 WHEREAS, At least two of the directors must possess significant knowledge of, or  
17 professional experience in, the field of public transportation; and,

18 WHEREAS, The Mayor has reappointed James McCray to the MTA Board of Directors  
19 to serve a term ending March 1, 2010; now, therefore, be it

20 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
21 does hereby confirm the reappointment of James McCray to the Board of Directors of the  
22 Municipal Transportation Agency for a term ending on March 1, 2010.




