5 **successor-in-interest for Decedent, Christopher Paul Kliment against the City and**  
6 **County of San Francisco for \$1,500,000; the lawsuit was filed on May 13, 2020, in**  
7 **United States District Court, Northern District of California, Case No. 20-cv-03257-YGR;**  
8 **entitled Michael Kliment, et al. v. City and County of San Francisco, et al.; the lawsuit**  
9 **involves alleged civil rights violations.**

11 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
13 authorizes the City Attorney to settle the action entitled Michael Kliment, et al. v. City and  
14 County of San Francisco, et al., United States District Court, Northern District of California,  
15 Case No. 20-cv-03257-YGR, the payment of \$1,500,000. The lawsuit involves alleged civil  
16 rights violations.

17 Section 2. The above-named action was filed in United States District Court, Northern  
18 District of California on May 13, 2020, and the following parties were named in the lawsuit:  
19 Plaintiffs Michael Kliment as co-successor-in interest for Decedent, Christopher Paul Kliment;  
20 Linda Kliment as co-successor-in-interest for Decedent, Christopher Paul Kliment; Defendants  
21 City and County of San Francisco.
