3 **Resolution designating the *Examiner* and the Chronicle as the official newspaper of the City and**  
4 **County of San Francisco for all official advertising for Fiscal Year 08-09.**

6 WHEREAS, in each year, the Board of Supervisors shall designate the official newspaper of the  
7 City and County of San Francisco, pursuant to Sections 2.80-1 and 2.81 of the San Francisco  
8 Administrative Code; now therefore, be it

9

10 RESOLVED, that the *Examiner* and the Chronicle, a newspapers of general circulation  
11 published in the City and County of San Francisco for the dissemination of local or telegraphic news  
12 and intelligence of a general character, having a bona fide circulation of at least 50,000 copies per  
13 calendar week, printed in the City and County on three or more days in a calendar week, are hereby  
14 designated as an official newspaper of the City and County of San Francisco, commencing July 1, 2008  
15 for the publication of all official advertising of the City and County which is required by law to be  
16 published two or more consecutive days, and advertising required by Section 2.103 of the Charter for  
17 special meetings of the Board of Supervisors and its special or standing committees; and, be it

19 FURTHER RESOLVED, that the Office of Contract Administration is hereby authorized to  
20 enter into a contract with the *Examiner* and the Chronicle and said contract must be in accordance with  
21 all the contracting requirements of the City and County of San Francisco.




