4 **Business Registry under the Office of Small Business and make it City policy to**  
5 **promote participation by Neighborhood Anchor Businesses in City grant programs for**  
6 **small businesses related to COVID-19 relief and for commercial eviction defense.**

14 Be it ordained by the People of the City and County of San Francisco:

15 Section 1. Article XVI of Chapter 2A of the Administrative Code is hereby amended by  
16 adding Sections 2A.244 and 2A.245, to read as follows:

17 **SEC. 2A.244. NEIGHBORHOOD ANCHOR BUSINESS REGISTRY.**

18 *(a) The Office of Small Business shall establish and maintain a registry of Neighborhood*  
19 *Anchor Businesses in San Francisco (“the Registry”).*

20 *(b) For purposes of this Section 2A.244 and Section 2A.245, “Neighborhood Anchor Business”*  
21 *means a business that either (1) is included in the Legacy Business Registry under Section 2A.242 of*  
22 *this Article, or (2) is designated pursuant to subsection (d), below, and meets all of the following*  
23 *criteria:*

24 *(1) The business has been in continuous operation in San Francisco for 15 or more*  
25 *years at the time of nomination, meaning there has been no break in San Francisco operations*

1 exceeding two years, provided that a period of non-operation during the COVID-19 pandemic shall not  
2 be considered a break in operations;

3 (2) The business has operated for that period in at least one physical location within a  
4 Neighborhood Commercial District (Planning Code Art. 7), Historic District (Planning Code Art. 10),  
5 ~~or~~ Conservation District (Planning Code Art. 11), or Cultural District (Administrative Code  
6 Chapter 107), or in a location that has subsequently been recognized as a Neighborhood Commercial  
7 District, Historic District, ~~or~~ Conservation District, or Cultural District. For purposes of this  
8 Section 2A.244, "Neighborhood Commercial District" shall include a Neighborhood  
9 Commercial Transit District and any other class of district established by Planning Code  
10 Section 702.

11 (3) The business has a total of 100 or fewer employees across all locations.

12 (c) A business shall not be eligible for inclusion in the Registry if there are any pending  
13 complaints against the business related to the violation of any worker protection law filed in  
14 court or it has an unpaid judgment with the California Division of Labor Standards Enforcement  
15 (DLSE), if there are any pending complaints against the business with the San Francisco Office  
16 of Labor Standards Enforcement (OLSE) or if the OLSE, the California Division of Occupational  
17 Safety and Health (Cal/OSHA), or the California Division of Workers' Compensation  
18 (hereinafter, "labor enforcement agencies"); if any court or labor enforcement agency has  
19 issued findings of misconduct against the business within the past five years that the business  
20 has violated any worker protection law, unless the relevant court or agency OLSE determines in  
21 writing that the misconduct has since been corrected or resolved; or if the business has any unpaid  
22 judgment against it based on a finding by a court or labor enforcement agency that the  
23 business violated any worker protection law. If a court or labor enforcement agency the OLSE  
24 issues such findings of misconduct against a business already included in the Registry, the inclusion of  
25

1 that business in the Registry shall automatically be suspended until the court or labor enforcement  
2 agency ~~OLSE~~ determines that the misconduct has been corrected or resolved.

3 (1) Any business nominated to the Neighborhood Anchor Business Registry  
4 must first, as condition of that nomination, submit a signed, sworn statement under penalty of  
5 perjury, in a form to be provided by the Office of Small Business, that the business is in  
6 compliance with this subsection (c). The business shall also disclose as a part of the  
7 statement whether it has any pending complaints against it before a court or labor  
8 enforcement agency for violation of a worker protection law.

9 (2) Any business included in the Registry must notify the Office of Small  
10 Business of any subsequent change in circumstances that would render its previous sworn  
11 statement inaccurate within 30 days of becoming aware of those changes.

12 (d) The Office of Small Business shall enter a proposed Neighborhood Anchor Business in the  
13 Registry as follows:

14 (1) The proposed Neighborhood Anchor Business must first be nominated by a local  
15 merchants association representing the neighborhood where the Business is located, nominated by  
16 the Small Business Commission, or recommended by petition signed by ~~2550~~ or more residents  
17 who live within a one-mile radius of the Business; The Executive Director of the Office of Small  
18 Business may, by regulation, identify additional community-based organizations that may  
19 nominate businesses for inclusion in the Registry, where the Executive Director determines  
20 that such organizations have an established connection to the local business community and  
21 that the addition of such organizations would advance the City's racial equity and language  
22 access goals.

23 (2) No merchants association or community-based organization may nominate  
24 more than 10 businesses for inclusion in the Registry in any year. The Small Business  
25

1 Commission may nominate no more than 10 businesses for inclusion in the Registry in any  
2 year. There shall be no cap on the number of nominations by petition permitted in a year;

3 (3) The Executive Director of the Office of Small Business shall determine whether  
4 the nomination meets the requirements of subsection (d)(1) and (2), above, and whether  
5 the proposed Neighborhood Anchor Business meets the requirements of subsection (b), above; and

6 (4)(3) The Executive Director specifies in the Registry the location or locations of the  
7 Neighborhood Anchor Business that meet the requirements of subsection (b)(d)(2), above.

8 (e) In order to remain on the Registry, a Neighborhood Anchor Business must continue to meet  
9 the criteria set in subsection (b).

10 (f) In addition to its duties under Section 2A.245, and subject to the fiscal and budgetary  
11 provisions of the Charter, the Office of Small Business may develop and submit to the Mayor and the  
12 Board of Supervisors for approval programs to preserve and grow Neighborhood Anchor Businesses,  
13 including programs for business and technical assistance, lease renewal and acquisition assistance,  
14 public education and commendation initiatives to recognize and honor the contributions of  
15 Neighborhood Anchor Businesses, and additional business stabilization and neighborhood continuity  
16 initiatives.

17 (g) To ensure that the implementation of the Neighborhood Anchor Business Registry  
18 program comports with the City's racial equity and language access goals and that the  
19 Registry includes an equitable balance of industries and types of businesses, the Office of  
20 Small Business shall, by October 1 of each year, prepare and submit to the Mayor and the  
21 Board of Supervisors a report on the characteristics and demographics of the businesses  
22 included in the Registry. The report shall include a breakdown of the businesses by industry  
23 type, the method of nomination to the Registry, the geographic distribution of the businesses,  
24 and the number of any requests for financial assistance or lease assistance made by the  
25 businesses through the Office of Small Business. The report shall also include summaries of

1 how many people are employed by the businesses in the Registry, the race or ethnicity of  
2 those employees, their gender identity, and the languages spoken by those employees, and  
3 summaries of the race or ethnicity of the owners or operators of the businesses, their gender  
4 identity, and the languages spoken by the owners or operators.

5 (h)(g) The Office of Small Business may, after a noticed hearing, adopt such rules, regulations  
6 and forms that are not inconsistent with this Section 2A.244 or its purposes and that will assist and  
7 guide departments in implementing this Section and Section 2A.245.

8  
9 **SEC. 2A.245. NEIGHBORHOOD ANCHOR BUSINESS REGISTRY; BUSINESS GRANTS AND**  
10 **LOANS; COMMERCIAL EVICTION DEFENSE.**

11 (a) It shall be City policy to include and, as appropriate, give priority to Neighborhood Anchor  
12 Businesses in the award and administration of any grant or loan program for San Francisco businesses  
13 related to relief or recovery from the COVID-19 emergency, subject to any applicable legal  
14 restrictions and consistent with the City's racial equity and language access goals. All City  
15 officers and departments shall cooperate with the Office of Small Business in carrying out this policy.  
16 No later than 30 days after the Office of Small Business issues an application form for the  
17 Registry program~~the effective date of this Section 2A.245, the Office of Small Business shall~~  
18 prepare a report identifying all such programs that have as of that date formally adopted and  
19 promulgated and their eligibility requirements. If the City adopts any such grant or loan  
20 programs after the effective date of this Section 2A.245, the Office of Small Business shall  
21 add the programs to the report no later than 30 days after the formal adoption of eligibility  
22 criteria for those programs. The Office of Small Business shall inform Neighborhood Anchor  
23 Businesses of such opportunities and assist them, as appropriate, in applying and qualifying for such  
24 programs.

1           (b) It shall be City policy to include and, as appropriate, give priority to Neighborhood Anchor  
2 Businesses in any commercial lease assistance, conflict resolution, or commercial eviction defense  
3 programs for San Francisco businesses, subject to any applicable legal restrictions and consistent  
4 with the City's racial equity and language access goals. All City officers and departments shall  
5 cooperate with the Office of Small Business in carrying out this policy. No later than 30 days after the  
6 Office of Small Business issues an application form for the Registry program the effective date  
7 of this ordinance, the Office of Small Business shall prepare a report identifying all such programs  
8 that have as of that date formally adopted and promulgated and their eligibility requirements. If  
9 the City adopts any such commercial lease assistance, conflict resolution, or commercial  
10 eviction defense programs after the effective date of this Section 2A.245, the Office of Small  
11 Business shall add the programs to the report no later than 30 days after the formal adoption  
12 of eligibility criteria for those programs. The Office of Small Business shall inform Neighborhood  
13 Anchor Businesses of such programs and assist them, as appropriate, in applying and qualifying for  
14 such programs.

15  
16           Section 2. Section 2A.244 of the Administrative Code is renumbered without change  
17 as Section 2A.249.

1           Section 3. Effective Date. This ordinance shall become effective 30 days after  
2 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
3 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
4 of Supervisors overrides the Mayor's veto of the ordinance.

**LEGISLATIVE DIGEST**

(Amended in Committee, 5/17/2021)

[Administrative Code - Neighborhood Anchor Business Registry]

**Ordinance amending the Administrative Code to create a Neighborhood Anchor Business Registry under the Office of Small Business and make it City policy to promote participation by Neighborhood Anchor Businesses in City grant programs for small businesses related to COVID-19 relief and for commercial eviction defense.**

Existing Law

The City currently has a number of programs to support small and neighborhood businesses, but does not have a specific program to benefit “Neighborhood Anchor Businesses.”

Amendments to Current Law

The proposed legislation is an ordinance that would amend the Administrative Code to create a program recognizing “Neighborhood Anchor Businesses” and making it City policy to support these businesses.

Under the proposal, the Office of Small Business would create a registry—or official list—of Neighborhood Anchor Businesses in San Francisco.

A business could get on the list in one of two ways. First, if the business already was a “Legacy Business” under the Administrative Code, it automatically would also be included on the Neighborhood Anchor Business Registry. Second, the Executive Director of the Office of Small Business would add a business to the Registry if the business met three requirements:

- The business had been in continuous operation in San Francisco for 15 or more years, with no break in those operations of more than two years, excluding any temporary closure of the business because of the COVID-19 pandemic;
- The business had operated during that time from at least one physical location within a Neighborhood Commercial District, Historic District, Conservation District, or Cultural District, as defined in the Planning and Administrative Codes; and,
- The business had a total of 100 or fewer employees across all locations.

The Executive Director would only select businesses that had been nominated by the Small Business Commission, nominated by a local merchants association, or recommended by a petition signed by 25 or more residents who lived within a one-mile radius of the business. The Executive Director could also accept nominations from additional community-based

organizations, identified by the Executive Director, that have an established connection to the local business community and whose inclusion would advance the City's racial equity and language access goals. The ordinance would require the Office of Small Business to prepare an annual report on the characteristics and demographics of the businesses included in the Registry.

The proposal would make it City policy to include Neighborhood Anchor Businesses in any grant or loan program for San Francisco businesses related to COVID-19 relief that the Anchor Businesses otherwise qualified for, or in any programs for commercial lease assistance, conflict resolution, or commercial eviction defense. And it would make it City policy to give priority to Anchor Businesses in those programs, where appropriate. The proposal would require the Office of Small Business to prepare a report identifying all such programs and their eligibility requirements, and direct the Office to inform Neighborhood Anchor Businesses of such opportunities and help the Businesses apply and qualify for such programs.

### Background Information

The Administrative Code currently provides for establishment of a San Francisco Legacy Business Registry. The registry is open to businesses that are 30 years or older, have been nominated by a member of the Board of Supervisors or the Mayor, and, in a hearing before the Small Business Commission, prove they have made a significant impact on the history or culture of their neighborhood. Only 300 businesses may be nominated for the Legacy Business Registry annually, and all applicants must agree to maintain the historical name and essential business operations, physical features, craft, and traditions of their businesses.

In addition, the Administrative Code establishes a Legacy Business Historic Preservation Fund. The Fund provides grants to both Legacy Business owners and to property owners who agree to lease extensions with Legacy Business tenants, subject to the availability of funds.

\* \* \*

The May 17 committee amendments made three additions to the proposed ordinance:

- The amendments authorized the Small Business Commission to nominate qualified businesses for inclusion in the Registry;
- The amendments reduced the number of neighborhood signatures required to nominate a business for inclusion in the Registry from 50 to 25; and
- The amendments added a requirement that the Office of Small Business prepare an annual report on the characteristics and demographics of the businesses included in the Registry.

Small Business Commission Recommendation to the Board of Supervisors: Approval with Two Recommends for Amendment:

1. Section 2A.244 (b)(2): Eligible nominees for the Neighborhood Anchoring Businesses Registry are for-profit businesses only.
2. Section 2a.244 (d): Allow the Executive Director of the Office of Small Business to establish through its rulemaking a third means for a business to apply for or be nominated to the Neighborhood Anchoring Business Registry to ensure the broadest representation of businesses to meet the racial and language access equity goals.

This motion passed 6 to 0, with 1 absence.

Dear Ms. Calvillo.

On February 26, 2021 and May 10, 2021, the Small Business Commission (SBC) heard BOS File No. 210303 - Administrative Code - Creating a Neighborhood Anchor Business Registry. At the February 26, 2021, the SBC provided a list of recommendations to amend the legislation. All but one is reflected in the amendments Supervisor Chan presented to the Rules Committee on May 10, 2021. This one recommendation is again reflected in the SBC's May 10, 2021 recommendation above. The SBC is also supportive of additional amendments Supervisor Chan presented, that improves the administration of the program. The SBC is very appreciative of Supervisor Chan and her aide Ian Fregosi for their continued engagement and work with the Office of Small Business and the SBC to ensure the best outcome in establishing a new and inspiring business recognition program.

The SBC strongly recommends this program is for-profit businesses only. The concept of an anchor business is a business that attracts people to a commercial district and therefore helps bring additional customer traffic to nearby businesses. Non-profits located in the defined areas of Section 2A.244 (b)(2) are funded through private and government grant programs that for-profit businesses are not eligible to apply for. In addition, non-profits are not eligible to receive support from traditional business funding and technical assistance programs, such as Legal Services for Entrepreneurs and the Small Business Development Center.

Members of the SBC expressed concerned that the proposed nomination process may still be a barrier for eligible businesses in being nominated, particularly businesses that are owned by and primarily serve immigrant communities. These businesses may not be associated with merchant association or other business entity and their customers are likely to be reluctant to sign a petition that is submitted to a government office. Therefore, the SBC second recommendation is to allow the Executive Director during

the rule making process, establish a third means in Section 2A.244 (d) a business can be nominated. The sole intent of establishing a third process is to ensure the nominations process is inclusive and reflects the City and County of San Francisco's racial and language equity access goals. In short, to ensure the traditionally marginalized and unrepresented businesses are included in the Neighborhood Anchor Business Registry.

San Francisco's merchant corridors help define the character of each of our individual neighborhoods.
