### **Article I - Summary Description of Award**

The terms of the approved Investment Justification(s) and Budget Detail Worksheet(s) submitted by the recipient are incorporated into the terms of this Federal award, subject to the additional description and limitations stated in this Agreement Article and the limitations stated in subsequent reviews by FEMA of the award budget. Investments not listed in this Agreement Article are not approved for funding under this award.

- Investment 1: 3D Sonar System Upgrade is fully funded for \$96000.
- Investment 2: Vessel Thermal Camera System is fully funded for \$162036.
- Investment 3: ROV Operator's Training is fully funded for \$24950.
- Investment 4: Response Vessel Refirbishing is fully funded for \$24750.
- Investment 5: 11m RHIB Response Boat is fully funded for \$854094.

### **Article II - Assurances, Administrative Requirements, Cost Principles, Representations and Certifications**

#### **Article XII - Debarment and Suspension**

Recipients are subject to the non-procurement debarment and suspension regulations implementing Executive Orders (E.O.) 12549 and 12689, which are at 2 C.F.R. Part 180 as adopted by DHS at 2 C.F.R.
