ADDING SECTION 32.6.26 TO THE SAN FRANCISCO TRAFFIC CODE, REGARDING PARKING REGULATIONS ON A PORTION OF BRANNAN STREET.

Note: This entire section is new.

Be it ordained by the people of the City and County of San Francisco:

Section 1. Article 3 of the San Francisco Traffic Code is hereby amended by adding Section 32.6.26 thereto to read as follows:

SEC. 32.6.26. PARKING CONTROL, PORTION OF BRANNAN STREET; PENALTIES FOR VIOLATION. No person shall stop, park, or leave standing any vehicle, whether attended or unattended, at the following locations:

- (a) Brannan Street, north side, from 15 feet to 115 feet east of Boardman Place (100-foot zone), and
- (b) Brannan Street, north side, from 16 feet to 116 feet west of Boardman Place (100-foot zone);

except official City-owned vehicles displaying a valid permit issued by the District Attorney's Office authorizing parking in such zones. The permit exceptions under this Section shall not apply when parking prohibition regulations for street-cleaning purposes are in effect. Violation of this Section is an obstruction to the free use of property and a nuisance within the meaning of Division 4. Part III of the Civil Code of California relating to nuisance and the abatement thereof.
