3 **Ordinance authorizing settlement of the lawsuit filed by Svetlana Hovhannisyan against**
4 **the City and County of San Francisco for \$120,000; the lawsuit was filed on**
5 **September 26, 2018, in San Francisco Superior Court, Case No. CGC-18-570140;**
6 **entitled Svetlana Hovhannisyan v. City and County of San Francisco, et al.; the lawsuit**
7 **involves alleged personal injury based on claims including medical negligence and**
8 **elder abuse.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
12 authorizes the City Attorney to settle the action entitled Svetlana Hovhannisyan v. City and
13 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-18-570140 by
14 the payment of \$120,000. The lawsuit involves alleged personal injury based on claims
15 including medical negligence and elder abuse.

16 Section 2. The above-named action was filed in San Francisco Superior Court on
17 September 26, 2018, and the following parties were named in the lawsuit: Plaintiff Svetlana
18 Hovhannisyan; Defendants City and County of San Francisco, Laguna Honda Hospital and
19 Rehabilitation Center; The Regents of The University of California.
