3 **Ordinance authorizing settlement of the lawsuit filed by Jonathan Manalang against the**
4 **City and County of San Francisco for \$105,000; the lawsuit was filed on August 26,**
5 **2024, in the United States District Court for the Northern District of California, Case No.**
6 **3:24-cv-05972; entitled Jonathan Manalang v. City and County of San Francisco, et al.;**
7 **the lawsuit involves an employment dispute.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Jonathan Manalang v. City and
12 County of San Francisco, et al., U.S. District Court, Northern District of California, Case No.
13 3:24-cv-05972 by the payment of \$105,000. The lawsuit involves an employment dispute.

14 Section 2. The above-named action was filed in the United States District Court for the
15 Northern District of California on August 26, 2024, and the following parties were named in the
16 lawsuit: Plaintiff Jonathan Manalang and Defendants City and County of San Francisco, San
17 Francisco Department of Public Health, and Laguna Honda Hospital and Rehabilitation
18 Center.
