

1 [Designation of Agents Authorized to Obtain Disaster and Emergency Assistance Funding]

3 **Resolution authorizing the Executive Director of the Department of Emergency**
4 **Management, Controller, and Deputy Controller as agents to act on behalf of the City**
5 **and County of San Francisco for all matters pertaining to State and Federal Disaster**
6 **and Emergency Assistance Funding and to provide the assurances and agreements**
7 **required by the Governor’s Office of Emergency Services.**

9 WHEREAS, Following the Mayor’s proclamation of a local emergency, the City and
10 County of San Francisco (the City) may, from time to time, be eligible for State and Federal
11 disaster assistance funding as provided in (a) the California Disaster Assistance Act and (b)
12 the Robert T. Stafford Disaster Relief and Emergency Assistance Act, as Amended; and

13 WHEREAS, The Governor’s Office of Emergency Services has requested the City to
14 designate agents authorized to obtain State and Federal disaster and emergency assistance
15 funding and to provide the assurances and agreements required by the Governor’s Office of
16 Emergency Services; and

17 WHEREAS, The Executive Director of the Department of Emergency Management
18 serves as the Executive Secretary of the Disaster Council and manages the Emergency
19 Response Plan for the City; and

20 WHEREAS, The Controller’s Office has been designated in the Emergency Response
21 Plan as the lead agency for the City’s Finance and Administration function, as per California’s
22 Standardized Emergency Management System, and is further designated as responsible for
23 management of the recovery of costs associated with the response to and recovery from
24 declared emergencies in the City; and

1 WHEREAS, This Resolution is effective for all existing and future disasters up to three
2 years following the date of its enactment; now therefore be it

3 RESOLVED, That the Mayor and Board of Supervisors designate the Executive
4 Director of the Department of Emergency Management, the Controller, and the Deputy
5 Controller, to be the agents authorized to execute agreements for and on behalf of the City for
6 disaster and emergency assistance funding from State and Federal agencies.
