9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Findings.

11 The Planning Department has determined that the actions contemplated in this
12 Ordinance are in compliance with the California Environmental Quality Act (California Public
13 Resources Code sections 21000 et seq.). Said determination is on file with the Clerk of the
14 Board of Supervisors in File No. 080756 and is incorporated herein by reference.

15 Section 2. The San Francisco Park Code is hereby amended by adding Section 12.48,
16 to read as follows:

17 **Sec. 12.48. ATHLETIC LEAGUES.**

18 (a) Definitions.

19 (1) Public Benefit Program – the activity is offered to low income communities and only
20 nominal fees are charged to ensure commitment to participation.

21 (2) Revenue Program – Fees are charged in order to offset the direct costs of the
22 program.

23 (3) For Profit Program – Fees are charged in order to cover the direct and indirect
24 costs of the program.

1 **(b) The following fees shall be charged for participation in athletic leagues. The Recreation**
 2 **and Park Department is authorized to set specific fees within each range based on the type of sport,**
 3 **hours of participation, duration of season, and other Department cost factors.**

<u>Public Benefit</u>	<u>\$10-25.00 per player</u>	<u>\$30-50.00 per player</u>

<u>For Profit Program</u>	<u>\$55-85.00 per player</u>	<u>\$85-100.00 per player</u>

 9 **leagues:**

<u>Futsal</u>	<u>\$250.00</u>	<u>\$450.00</u>
<u>Seven-A-Side Soccer</u>	<u>\$250.00</u>	<u>\$450.00</u>
<u>Women's Volleyball</u>		<u>\$310.00</u>
<u>Women's Basketball</u>		<u>\$500.00</u>




