AUTHORIZING THE DEPARTMENT OF PUBLIC HEALTH, COMMUNITY HEALTH NETWORK, PRIMARY CARE SERVICES, TO ENTER INTO AN AGREEMENT AS SUBCONTRACTOR WITH LUTHERAN SOCIAL SERVICES, THE PRIMARY CONTRACTOR, IN THE AMOUNT OF \$90,994, TO PROVIDE PREVENTATIVE AND PRIMARY HEALTH CARE SERVICES AND WHICH INCLUDES AN INDEMNIFICATION CLAUSE AND WHICH DOES NOT INCLUDE PATENT INFRINGEMENT INDEMNIFICATION AND FALSE CLAIMS CLAUSES; RETROACTIVE TO OCTOBER 1, 1997.

WHEREAS, Lutheran Social Services has been awarded a grant from the US. Department of Housing and Urban Development for a collaborative effort to provide housing, mental health, substance abuse counseling, benefits counseling, nursing, primary care, and alternative therapy to multiple diagnosed persons with HIV; and

WHEREAS, Lutheran Social Services requires the City to enter into an agreement (the "Agreement") to provide a portion of these services, a copy of which agreement is on file with the Clerk of the Board of Supervisors in File No. _____; and

WHEREAS, The Agreement specifies that the maximum dollar obligation of Lutheran Social Services under this agreement shall not exceed \$90,994, and

WHEREAS, Lutheran Social Services has indicated that it will not agree to any modification to the form of the Agreement; and,

WHEREAS, The Agreement contains certain provisions described below, which require the approval of the Board of Supervisors; and,

WHEREAS, The Agreement does not contain certain provisions described below, which are required under the Administrative Code unless waived by the Board of Supervisors; and,

WHEREAS, The Board of Supervisors desires to authorize the Department of Public Health, on behalf of the City, to enter into the Agreement in order to receive and expend these funds for this

and any future years; now, therefore, be it

RESOLVED, That the Department of Public Health is hereby authorized to accept and expend these funds pursuant to San Francisco Administrative Code section 10.170-1; and, be it

FURTHER RESOLVED, That the Director of Health is authorized to enter into the Agreement on behalf of the City; and, be it

FURTHER RESOLVED, That the Board of Supervisors hereby approves the provision in the Agreement pursuant to which the City indemnifies Lutheran Social Services; and, be it

FURTHER RESOLVED, That the Board of Supervisors hereby waives the requirement contained in Sections 6.21 and 21.19 of the Administrative Code that the Agreement include an indemnification of the City by Lutheran Social Services for the infringement of patent rights; and, be it

FURTHER RESOLVED, That the Board of Supervisors hereby waives the requirement contained in Section 6.57 (c) of the Administrative Code that the Agreement include a paragraph reciting the false claim provisions contained in Section 6.57 (a) of the Administrative Code: and, be it

FURTHER RESOLVED, That the Board of Supervisors authorizes the Department of Public Health to enter into similar agreements with Lutheran Social Services if the grant recurs or is renewed.
