Resolution appointing Karin Jensen (residency requirement waived), term ending August 20, 2005 and Christine Luong, term ending August 20, 2003 to the Lead Poisoning Prevention Citizens Advisory Committee.

RESOLVED, That the Board of Supervisors of the City and County of San Francisco does hereby appoint the hereinafter designated persons to serve as members of the Lead Poisoning Prevention Citizens Advisory Committee, pursuant to the provisions of the San Francisco Health Code, Section 1607, for the term specified:

Karin Jensen (residency waiver required), succeeding James Threat, term expired, Seat No. 8, must represent the Recreation and Park Department, for the unexpired portion of a four-year term ending August 20, 2005.

Christine Luong, succeeding Jerry Rogers, resigned, Seat No. 21, must have expertise in non-profit clinics, for the unexpired portion of a four-year term ending August 20, 2003.

FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 1. The membership of the Lead Poisoning Prevention Center has a goal to be representative of the diversity of the City and County of San Francisco.
- Applicant Karin Jensen, a new appointee, who is not a resident of San Francisco, is a person with experience that uniquely qualifies him/her to serve on the Lead Poisoning Prevention Citizens Advisory Committee.
- 3. The Lead Poisoning Prevention Citizens Advisory Committee has attempted to fill the position, for which Karin Jensen was nominated, with an individual who is a City resident and who has the specific experience, skills, and qualifications, but has been unable to do so at this time. The Rules Committee has certified that Karin

Jensen is qualified to serve on the Lead Poisoning Prevention Citizens Advisory Committee.

4. After exercising due diligence, the Board of Supervisors concludes that there is no other possible representative, who is a resident of San Francisco and who has the specific experience, skills, or qualifications possessed by this applicant, and who is willing to serve on the Lead Poisoning Prevention Citizens Advisory Committee at this time; and, be it

FURTHER RESOLVED, That the Board of Supervisors waives the residency requirement for Karin Jensen, as allowed in cases where no qualified City resident, willing to serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s) appointed to boards, commissions, and advisory bodies established by legislative act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.
