8 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
9 does hereby appoint the hereinafter designated persons to serve as members of the
10 Live/Work Task Force, pursuant to the provisions of Resolution No. 276-01, for the term
11 specified:

12 James Meko, new appointment, Seat 1, must be a representative of neighborhood
13 organizations representing supervisorial district 6, for a new term ending June 30, 2001;

14 Eric Quezada, new appointment, Seat 2, must be a representative of neighborhood
15 organizations representing supervisorial district 9, for a new term ending June 30, 2001;

16 Janet Carpinelli, new appointment, Seat 3, must be a representative of neighborhood
17 organizations representing supervisorial district 10, for a new term ending June 30, 2001;

18 Jamie Rossi, new appointment, Seat 4, must be a representative of a business
19 association, for a new term ending June 30, 2001;

20 Stanley Warren (residency requirement waived), new appointment, Seat 5, must be a
21 representative of organized labor, for a new term ending June 30, 2001;

22 Tom Radulovich, new appointment, Seat 6, must be a representative of an urban
23 planning association, for a new term ending June 30, 2001;

24 Carlos Romero (residency requirement waived), new appointment, Seat 7, must be a
25 representative of an affordable housing organization, for a new term ending June 30, 2001;

1 Robert Haaland, new appointment, Seat 8, must be a representative of a tenant
2 organization, for a new term ending June 30, 2001;

3 Debra Walker, new appointment, Seat 9, must be a representative who is an artist or
4 represents an arts organization, for a new term ending June 30, 2001;

5 Michael Strausz, new appointment, Seat 10, must be a representative who is a
6 residential builder, for a new term ending June 30, 2001; and, be

7 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 8 1. The membership of the Live/Work Task Force has a goal to be representative of the
9 diversity of the City and County of San Francisco.
- 10 2. Applicants Stanley Warren and Carlos Romero, new appointees, who are not
11 residents of San Francisco, are persons with experience that uniquely qualifies
12 him/her to serve on the Live/Work Task Force.
- 13 3. The Live/Work Task Force has attempted to fill the positions, for which Stanley
14 Warren and Carlos Romero were nominated, with individuals who are City residents
15 and who have the specific experience, skills, and qualifications, but has been
16 unable to do so at this time. The Rules Committee has certified that Stanley
17 Warren and Carlos Romero are qualified to serve on the Live/Work Task Force.
- 18 4. After exercising due diligence, the Board of Supervisors concludes that there are no
19 other possible representatives, who are residents of San Francisco and who have
20 the specific experience, skills, or qualifications possessed by these applicants, and
21 who are willing to serve on the Live/Work Task Force at this time; and, be it

22 FURTHER RESOLVED, That the Board of Supervisors waives the residency
23 requirement for Stanley Warren and Carlos Romero, as allowed in cases where no qualified
24 City resident, willing to serve, can be found, pursuant to Section 4.101 of the City Charter that
25 requires person(s) appointed to boards, commissions, and advisory bodies established by

1 legislative act of the Board of Supervisors to be resident(s) of the City and County of San
2 Francisco.


