Be it ordained by the People of the City and County of San Francisco:

Section 1. Environmental Findings. The Planning Department has determined that the actions contemplated in this Ordinance are exempt from the California Environmental Quality Act (California Public Resources Code section 21000 et seq.). Said determination is on file with the Clerk of the Board of Supervisors in File No. I and is incorporated herein by reference.

Section 2. The San Francisco Administrative Code is hereby amended by amending Section 8.14, to read as follows:

Sec. 8.14. Medical Examiner's Fees for Copies of Documents and Certain Services.

(a) The Medical Examiner is hereby authorized to charge fees to defray the cost of the issuance of the following mentioned documents and the providing of the following services.

Any persons requesting or requiring such documents or services shall pay the following fees:

- (b) Beginning with fiscal year 2003-2004, fees set in this Section may be adjusted each year, without further action by the Board of Supervisors, to reflect changes in the relevant Consumer Price Index, as determined by the Controller.

(5) Cases in which private charitable funds available to pay funeral costs would thereby

No later than April15th of each year, the Medical Examiner's Office shall submit its current fee schedule to the Controller, who shall apply the price index adjustment to produce a new fee schedule for the following year.

No later than May 15th of each year, the Controller shall file a report with the Board of Supervisors reporting the new fee schedule and certifying that: (a) the fees produce sufficient revenue to support the costs of providing the services for which each fee is assessed, and (b) the fees do not produce revenue which is significantly more than the costs of providing the

be reduced so as to preclude payment;

services for which each fee is assessed. <u>The Controller shall, if necessary, adjust the fees upward or downward for the upcoming fiscal year as appropriate to ensure that the Medical Examiner's Office recovers the costs of operation without producing revenue that is significantly more than such costs. The adjusted rates shall become operative on July 1.</u>

(c) All fees received for documents and services mentioned in this Section shall be deposited with the Treasurer and shall be used to defray the costs incurred by the Medical Examiner in issuing such documents or providing such services.
