11 landmarks including the Castro Camera and Harvey Milk Residence, Columbus Savings Bank

13 House; and,

14 WHEREAS, Supervisor Becerril has devoted countless hours and energy in meeting
15 with members of the public and holding hearings to discuss issues such as health, land use,
16 transportation, and firearms; and,

17 WHEREAS, Supervisor Becerril established a Joint Board of Education/Board of
18 Supervisors Digital Task Force to work to ameliorate the digital divide in San Francisco by
19 ensuring greater access to the tools of the digital economy among disadvantaged students;

21 WHEREAS, Supervisor Becerril has served on the San Francisco County
22 Transportation Authority and numerous Board of Supervisors' Standing Committees,
23 including, but not limited to, a member of the Small Business, Economic Vitality and
24 Consumer Services Committee, Housing and Social Policy Committee, and Public Utilities
25 and Deregulation Committee; now, therefore, be it

1 RESOLVED, That the members of the Board of Supervisors, on behalf of the officers,
2 employees and citizens of this City, do hereby take public recognition of the distinguished
3 contributions which Supervisor Alicia Becerril has made to the welfare of this community, and
4 do express to her their appreciation for her high quality work, their thanks for her presence,
5 and their hopes for the best in her future endeavors; and, be it




