15 Board of Supervisors may plan to be away from the Board without missing any Board or  
16 Committee meetings or other important public business, and without causing difficulties in  
17 achieving a quorum, the Board of Supervisors now wishes to follow the tradition established  
18 by many other sitting legislative bodies in the United States and provide for a scheduled  
19 recess period, and selects the period from August 18 through September 6, 2004 for this  
20 recess; now, therefore, be it,

21 RESOLVED, That the meetings of the Board of Supervisors scheduled for November  
22 30, 2004 and December 28, 2004, are cancelled; and, be it

23 FURTHER RESOLVED, That the Board and Committee meetings of the Board of  
24 Supervisors scheduled from August 18 through September 6, 2004, are canceled.


