Ordinance amending the San Francisco Park Code, Article 12, by amending Section 12.35, to increase the fees at the Golden Gate Park Concourse Underground Parking Facility, and making environmental findings.

Be it ordained by the People of the City and County of San Francisco:

Section 1. The San Francisco Park Code is hereby amended by amending Section 12.35, to read as follows:

SEC. 12.35. GOLDEN GATE PARK CONCOURSE UNDERGROUND PARKING FACILITY.

(a) The rates for parking in the Golden Gate Park Underground Parking Facility shall be as follows:

Weekdays	\$2.50 <u>\$3.50</u>	\$18.00 <u>\$25.00</u>
Weekends	\$3.00 <u>\$4.00</u>	\$22.00 <u>\$28.00</u>
Flat Rate After 6:00 p.m.		\$10.00 <u>\$12.00</u>
"Early Bird" Rate: In between 7:00 a.m. and 8:30 a.m., out by 6:00 p.m.		\$10.00 <u>\$11.00</u>
Monthly Rate (daytime)		\$125.00 <u>\$200.00</u>

1 (b) The deposit and expenditure of all amounts collected from this facility are
2 subject to the provisions of the "Golden Gate Park Revitalization Act of 1998," Appendix 41 of
3 the Administrative Code.
