8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby  
10 authorizes the City Attorney to settle the action entitled Travis Jones v. City and County of  
11 San Francisco, et al., United States District Court, Case No. CV 14-00733 NC by the payment  
12 of \$60,000. Contra Costa County is also a party to the case and will pay \$65,000 in  
13 settlement of the claims against Contra Costa County.

14 Section 2. The above-named action was filed in the United States District Court on  
15 February 18, 2014, and the following parties were named in the lawsuit: Plaintiff Travis  
16 Jones; Defendants City and County of San Francisco and Contra Costa County.




