9 of San Francisco to allow committee meetings of the San Francisco Board of Supervisors to
10 be held outside of City Hall; and

11 WHEREAS, The 1996 Charter Section 2.103 continued to allow meetings of the San
12 Francisco Board of Supervisors committees to be held outside of City Hall; and

13 WHEREAS, The Board of Supervisors on January 14, 2002, adopted Rule 5.7 of its
14 Rules of Order which created the City and School District Committee to hear measures
15 concerning issues of mutual interest that affect the City and School District, its employees,
16 its students, and the families of its students, including the issue of the public use of the
17 School District facilities; and

18 WHEREAS, The Board of Education on June 22, 1999 adopted Rule 5.6, Policy No.
19 P120, creating the City and School District Committee with the same purpose as cited
20 above and stating the City and School District Committee shall be comprised of two
21 members of the Board of Supervisors and two members of the Board of Education; and,

22 WHEREAS, At the October 24, 2001 meeting of the City and School District
23 Committee, it was decided to hold bi-monthly meetings at the Irving G. Breyer Board
24 Meeting Room, Board of Education, 555 Franklin Street, First Floor, San Francisco at 3:00
25 p.m.; now, therefore, be it


