3 **Resolution proclaiming September 10, 2002 as “Brotherhood Way Remembrance Day”**
4 **in the City and County of San Francisco in honor of the ecumenical prayer service and**
5 **candlelight vigil involving the congregations of Brotherhood Way in remembrance of**
6 **the attacks of September 11, 2001.**

8 WHEREAS, In late 1957 through 1958, the City and County of San Francisco
9 conveyed parcels of real property, along what is now referred to as Brotherhood Way, to
10 several religious organizations for religious and educational uses; and

11 WHEREAS, In or about March 1958, the Board of Supervisors enacted an ordinance
12 changing the name of Stanley Drive to Brotherhood Way; and

13 WHEREAS, At all times thereafter, all properties on the south side of Brotherhood
14 Way have been, and continued to be, used for religious and educational purposes; and,

15 WHEREAS, Today, there exists a Catholic church and school, a Jewish synagogue
16 and school, a Greek Orthodox church and school, an Armenian church and school, a
17 Christian church, and a non-denominational private junior high school and high school; and,

18 WHEREAS, On September 10, all the congregations along Brotherhood Way will join
19 together in an ecumenical prayer service and a candlelight vigil bringing together students
20 and adults from a broad spectrum of nationalities and faiths in remembrance of the
21 September 11, 2001 attacks on the World Trade Center and Pentagon; and,

22 WHEREAS, This prayer service and candlelight vigil is yet another fine example of the
23 Brotherhood Way community coming together and living up to the spirit of their street name;
24 now, therefore, be it

1 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
2 hereby proclaims September 10, 2002 as "Brotherhood Way Remembrance Day" in the City
3 and County of San Francisco in honor of the ecumenical prayer service and candlelight vigil
4 involving the congregations of Brotherhood Way in remembrance of the attacks of September
5 11, 2001.


