Hello Supervisors Haney, Safai and Mar,

The Department of Public Health (DPH) will request approval for one item at the April 14th Budget & Finance Committee meeting. Please see below for a brief description of the item and our DPH representative who may be contacted should you have any questions.

Agenda item #4 – File no. 210250 - Contract Amendment - Central City Hospitality House - Behavioral Health Services - Not to Exceed \$15,093,612 - Resolution approving Amendment No. 1 to the agreement between Central City Hospitality House and the Department of Public Health, for behavioral health services, to increase the agreement by \$6,289,377 for an amount not to exceed \$15,093,612; and to extend the term by one and one-half years from June 30, 2021, for a total agreement term of July 1, 2018, through December 31, 2022.

- **Description:** In 2017, DPH entered into a three-year contract with Central City Hospitality House (CCHH) - from July 1, 2018 through June 30, 2021. Central City Hospitality House is a nonprofit organization that provides behavioral health services to adults and older adults. The proposed resolution would approve the first amendment to the contract between DPH and CCHH to provide an additional \$6.3 million and extend the funding for four programs for the 1.5-year period from June 30, 2021 through December 31, 2022. The four programs include: The Tenderloin Self-Help Center, the Sixth Street Self-Help Center, the Community Building Program and the Homeless Mentally Ill Outreach and Treatment Program.
