3 **Resolution authorizing the San Francisco Board of Supervisors to accept and expend**  
4 **\$275,000 in AB 471 funds from the California Resources Agency, Environmental**  
5 **Enhancement and Mitigation Program to fund Americans with Disabilities Act (ADA)**  
6 **and other improvements to Tulare Park**

8 WHEREAS, The California Legislature enacted AB 471 (Chapter 106 of the Statutes of  
9 1989), which is intended to provide \$10 million annually for a period of 10 years for grants to  
10 local, state and federal agencies and nonprofit entities for projects to enhance and mitigate  
11 the environmental impacts of modified or new public transportation facilities; and,

12 WHEREAS, Tulare Park is located adjacent to the Illinois Street Intermodal Bridge  
13 project and is eligible for AB 471 funds by virtue of its relationship to this project; and,

14 WHEREAS, On June 7, 2007, the Port was allocated \$275,000 in AB 471 funds from  
15 the California Resources Agency, Environmental Enhancement and Mitigation Program for  
16 improvements to Tulare Park, including ADA accessibility requirements, as well as  
17 connections to other open spaces, re-landscaping, and installation of new park amenities,  
18 including benches, lighting, signage and trash receptacles; and,

19 WHEREAS, On May 8, 2007, through Commission Resolution No. 07-34, the Port  
20 Commission authorized the Executive Director of the Port to enter into an agreement with the  
21 California Resources Agency to accept and expend these grant funds; and,

22 WHEREAS, The grant does not create any new positions, and will not require an  
23 amendment to the Annual Salary Ordinance; and,

10 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
11 indirect costs in the grant budget; and be it

12 FURTHER RESOLVED, That the Executive Director of the Port, or her designee, is  
13 authorized to approve, sign and execute an agreement to hold the granting agency harmless  
14 from liability arising out of the Project.
