We want the city to implement CART. CART will provide community organizations with culturally competent training and resources that will help them build relationships with unhoused neighbors who they directly work with.

If implemented, and implemented correctly, CART will improve outcomes for folks on the streets. A police response exacerbates homelessness by wasting resources, displacing unhoused community members away from their support system and issuing citations which destroy individuals' credit when those tickets go unpaid, or lead to violence. A CART response would focus on moving people off the streets permanently and addressing the immediate needs of all those involved, instead of just moving homeless people around. When successfully implemented, CART will provide our communities with alternatives to alleviate the stigma behind homelessness and the social issues unaddressed by our civic systems.
