3 **Resolution appointing Charles Striplen, term ending April 21, 2004 to the San Francisco**
4 **Museum and Historical Society Advisory Committee. Residency requirement waived.**

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
7 does hereby appoint the hereinafter designated person to serve as a member of the San
8 Francisco Museum and Historical Society Advisory Committee, pursuant to the provisions of
9 the Administrative Code Article VIII, section 2A.166, for the term specified:

10 Charles Striplen, new position, Seat No. 3, must be a member from organizations or
11 communities with extensive knowledge of the history or cultural traditions of an ethnic minority
12 community within San Francisco with a focus on ancestral lineage or other historical and
13 cultural links to the San Francisco Bay area, for a one year term ending April 21, 2004; and,
14 be it

15 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 16 1. The membership of the San Francisco Museum and Historical Society Advisory
17 Committee has a goal to be representative of the diversity of the City and County of
18 San Francisco.
- 19 2. Applicant Charles Striplen, a new appointee, who is not a resident of San
20 Francisco, is a person with experience that uniquely qualifies him/her to serve on
21 the San Francisco Museum and Historical Society Advisory Committee.
- 22 3. The San Francisco Museum and Historical Society Advisory Committee has
23 attempted to fill the position, for which Charles Striplen was nominated, with an
24 individual who is a City resident and who has the specific experience, skills, and
25 qualifications, but has been unable to do so at this time. The Rules Committee has

- 4. After exercising due diligence, the Board of Supervisors concludes that there is no other possible representative, who is a resident of San Francisco and who has the specific experience, skills, or qualifications possessed by this applicant, and who is willing to serve on the San Francisco Museum and Historical Society Advisory Committee at this time; and, be it

FURTHER RESOLVED, That the Board of Supervisors waives the residency requirement for Charles Striplen, as allowed in cases where no qualified City resident, willing to serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s) appointed to boards, commissions, and advisory bodies established by legislative act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.
