RESOLUTION NO. 24-0138

WHEREAS, San Francisco Public Utilities Commission (SFPUC) Water Enterprise staff requires the support of consultants to assist with managing and monitoring SFPUC watershed lands and meeting the requirements for SFPUC's permit related mitigation obligations; and

WHEREAS, Qualified consulting services are necessary to supplement SFPUC staff to provide specialized and technical support, including ecological analysis, planning, permitting, and environmental regulatory compliance services, land and natural resource management services, and habitat restoration planning and natural resource protection services; and

WHEREAS, On August 28, 2018, by Resolution No. 18-0141, this Commission awarded Contract Nos. PRO.0066.A to C, Natural Resources Specialized and Technical Services, each with an amount not to exceed \$14,000,000 and a duration of 10 years, to AECOM Technical Services, Inc (PRO.0066.A), Applied Technology and Science A-T-S (PRO.0066.B), and Avila and Associates Consulting Engineers Inc. (PRO.0066.C); and

WHEREAS, Staff recommends the Commission approve an increase of \$7,000,000 for each contract, with no change each contract duration, increasing each contract's not-to-exceed amount to \$21,000,000; and

WHEREAS, The Contract Monitoring Division (CMD) established a Local Business Enterprise (LBE) subconsulting requirement of 10% for these contracts. AECOM Technical Services, Inc (PRO.0066.A), Applied Technology and Science A-T-S (PRO.0066.B), and Avila and Associates Consulting Engineers Inc. (PRO.0066.C) each committed to LBE subconsultant participation of 10%, 10%, and 10.3% respectively with their proposals, and these amounts remain unchanged; and

WHEREAS, Funds for each of these agreements will be available at the time of individual task order awards from Water Enterprise operating and capital budgets, now, therefore, be it

RESOLVED, That this Commission hereby approves Amendment No. 1 to Contract Nos. PRO.0066 A to C, Natural Resources Specialized and Technical Services, with AECOM Technical Services, Inc (PRO.0066.A), Applied Technology and Science A-T-S (PRO.0066.B), and Avila and Associates Consulting Engineers Inc. (PRO.0066.C), increasing each contract amount by \$7,000,000, with no change to each contract duration, each for a total not-to-exceed contract amount of \$21,000,000, subject to Board of Supervisors approval pursuant to Charter Section 9.118.
