

1 [Accept-Expend State Grant]

2 AUTHORIZING THE SHERIFF'S DEPARTMENT TO APPLY FOR, ACCEPT AND EXPEND  
3 THE AMOUNT OF \$ 62,100 FROM THE STATE BOARD OF CORRECTIONS PURSUANT  
4 TO THE MENTALLY ILL OFFENDER CRIME REDUCTION GRANTS PROGRAM (MIOCR);  
5 AND, APPROVING THE MEMBERSHIP OF THE MIOCR STRATEGY COMMITTEE.

7 WHEREAS, Due to the deinstitutionalization of severely mentally  
8 ill individuals that occurred in the 1970, many mentally ill people  
9 now remain untreated, resulting in impaired functioning, poverty,  
10 homelessness and self-medication with alcohol and controlled  
11 substances; and,

12 WHEREAS, These behaviors often necessitate police intervention  
13 resulting in incarceration; and,

14 WHEREAS, The State Board of Corrections has made available  
15 funding, through Mentally Ill Offender Crime Reduction grants, for  
16 development of programs designed to address the needs of mentally ill  
17 offenders during incarceration and upon release; and,

18 WHEREAS, The State requires that the Board of Supervisors  
19 authorize the Sheriff to apply for, accept and expend such funding,  
20 including indirect costs, assisted by a Strategy Committee consisting  
21 of mental health professionals and representatives from affected City  
22 and criminal justice agencies; now, therefore, be it

23 RESOLVED, That the Board of Supervisors of the City and County  
24 of San Francisco authorizes Sheriff Michael Hennessey to apply for,  
25 accept and expend \$ 62,100 of MIOCR funding for the purpose of

21 to sign the City and County of San Francisco's application for State  
22 funding as well as related contracts, amendments or extensions with  
23 the State of California; and be it

24 FURTHER RESOLVED, That the City and County of San Francisco will  
25 adhere to the requirements of the Board of Corrections and all


1 conditions specified in the grant contract with the State of




