2 ENACTING AND RESCINDING PARKING REGULATIONS AT VARIOUS LOCATIONS.

3 RESOLVED, That, in accordance with the provisions of the California Vehicle Code and
4 the San Francisco Traffic Code, the following regulations governing the parking of vehicles are
5 hereby enacted or rescinded as designated below:

6 **PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH**

7 8th Street, east side, between 15th and Irwin Streets

8 Carolina Street, both sides, between 15th and Channel Streets

9 Carolina Street, east side, from 16th Street to 210 feet northerly (210-foot zone, parallel
10 parking to be permitted for remainder of block)

11 **1-HOUR PARKING TIME LIMIT, 7 AM - 6 PM, MONDAY THROUGH SATURDAY - RESCIND
RESIDENTIAL PERMIT PARKING AREA "I" (1-HOUR TIME LIMIT, 9 AM - 6 PM, MONDAY
THROUGH FRIDAY) - ESTABLISH**

12 Capp Street, both sides, between 21st and 22nd Streets (600 block)

13 **RESIDENTIAL PERMIT PARKING AREA "J" (2-HOUR TIME LIMIT, 8 AM - 5 PM, MONDAY
THROUGH FRIDAY) - ESTABLISH**

14 9th Avenue, both sides, between Kirkham and Lawton Streets (1500 block)

15 9th Avenue, both sides, between Moraga and Noriega Streets (1700 block)

16 **RESIDENTIAL PERMIT PARKING AREA "W" (1-HOUR TIME LIMIT, 8 AM - 6 PM, MONDAY
THROUGH FRIDAY) - ESTABLISH**

17 24th Street, both sides, between Rhode Island and De Haro Streets (2100 block)

18 **UNMETERED MOTORCYCLE PARKING - RESCIND**

19 Main Street, east side, from 218 feet to 318 feet north of Mission Street (100-foot zone)


