7 **Guardian ad Litem, Jasmine Robinson v. City of San Francisco, et al.; the lawsuit**
8 **involves alleged civil rights violations.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
12 authorizes the City Attorney to settle the action entitled Deshaun Roberts, by and through his
13 Guardian ad Litem, Jasmine Robinson v. City and County of San Francisco, et al., United
14 States District Court, Case No. 3:19-cv-5280 by the payment of \$55,000. The lawsuit involves
15 alleged civil rights violations.

16 Section 2. The above-named action was filed in United States District Court on August
17 23, 2019, and the following parties were named in the lawsuit: plaintiff Deshaun Roberts, by
18 and through his Guardian ad Litem, Jasmine Robinson; defendants City and County of San
19 Francisco and Alex Jayson.
